**Date Founded:** Parkview Health System Inc. was incorporated in May 1995. Parkview Whitley and Parkview Huntington Hospitals joined the system in 1995, Parkview Noble Hospital in 2000, Parkview LaGrange Hospital in 2005, Parkview Wabash Hospital in 2015, Parkview DeKalb Hospital in 2019, Parkview Bryan and Parkview Montpelier hospitals in 2023, and Parkview Logansport in 2025.

In 2009, PMG became Parkview Physicians Group (PPG) with the acquisition of primary care physicians, specialists in cardiovascular and colorectal surgery, and OB/GYN. Now, PPG includes more than 1,300 providers in more than 40 specialties in nearly 300 locations throughout Indiana and northwest Ohio.

**Parkview Research Center:** A research function participating in national and international medical research that brings the newest technology and medical breakthroughs to the Fort Wayne area.

**Parkview Employer Solutions:** A combination of four service lines aimed at improving the financial health of area companies and the physical and mental health of their employees. Includes the Signature Care PPO network, Occupational Health, Employee Assistance Program, and Workplace Wellness.
