Objectives of the Community Health Needs Assessment

- As a not-for-profit hospital system, Parkview Health is responsible for conducting a CHNA every 3 years for each community served by a Parkview Hospital. The last CHNA was completed in 2022.
- Data from the CHNA is used to identify priority health needs in the communities we serve and is integral to Parkview's community health improvement strategies and investments.

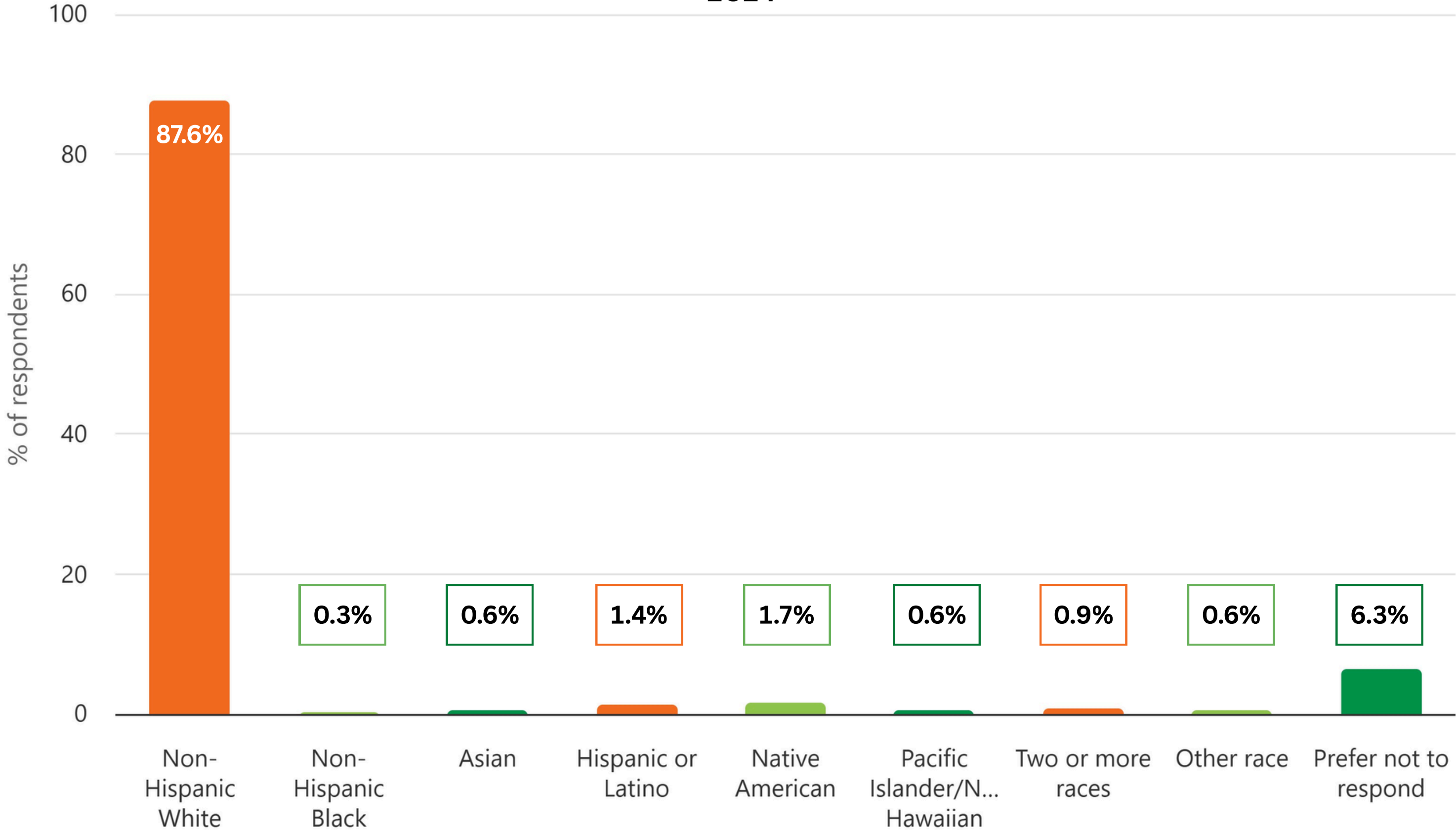

Community Survey: Race/ethnicity of respondents

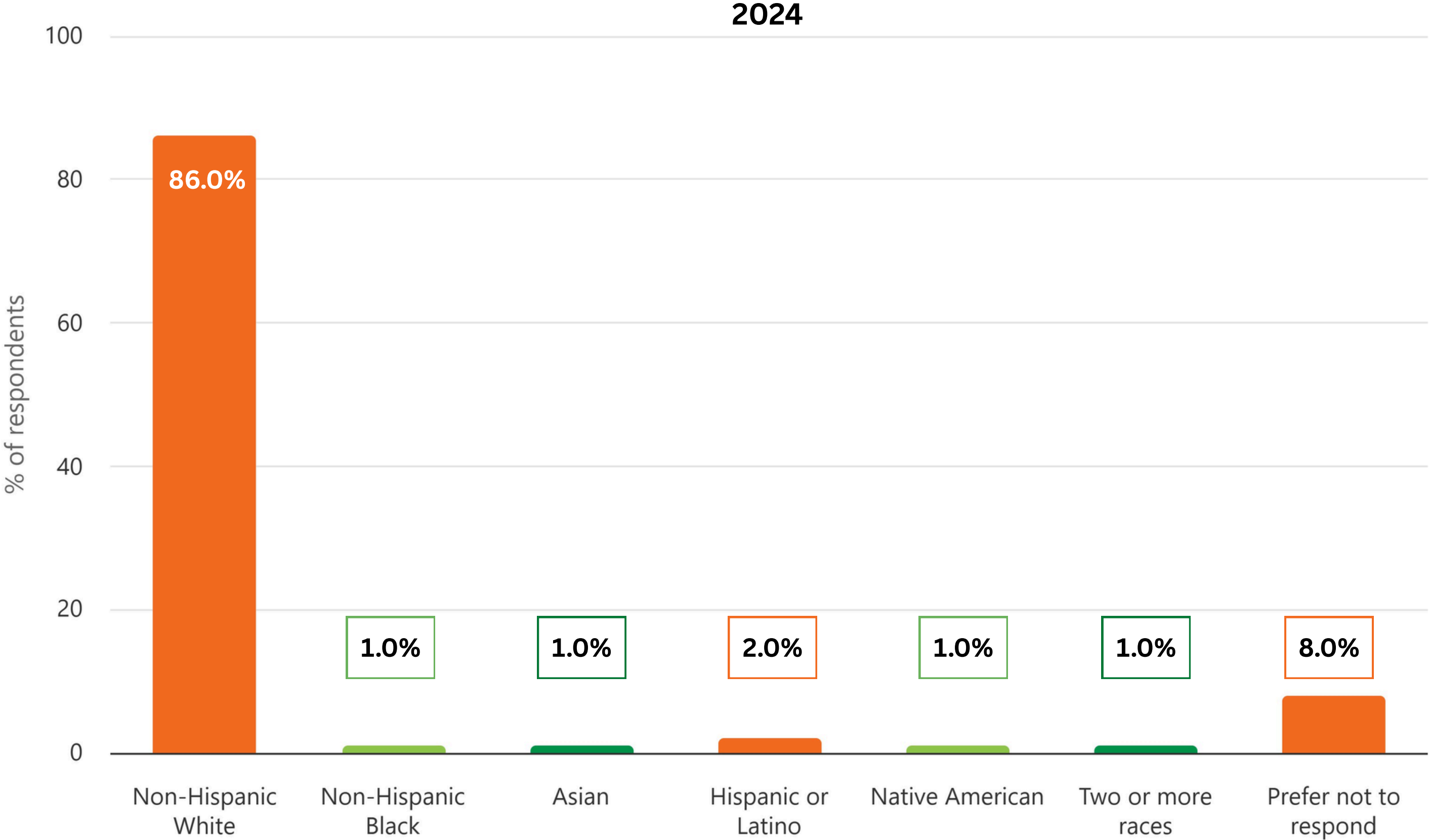

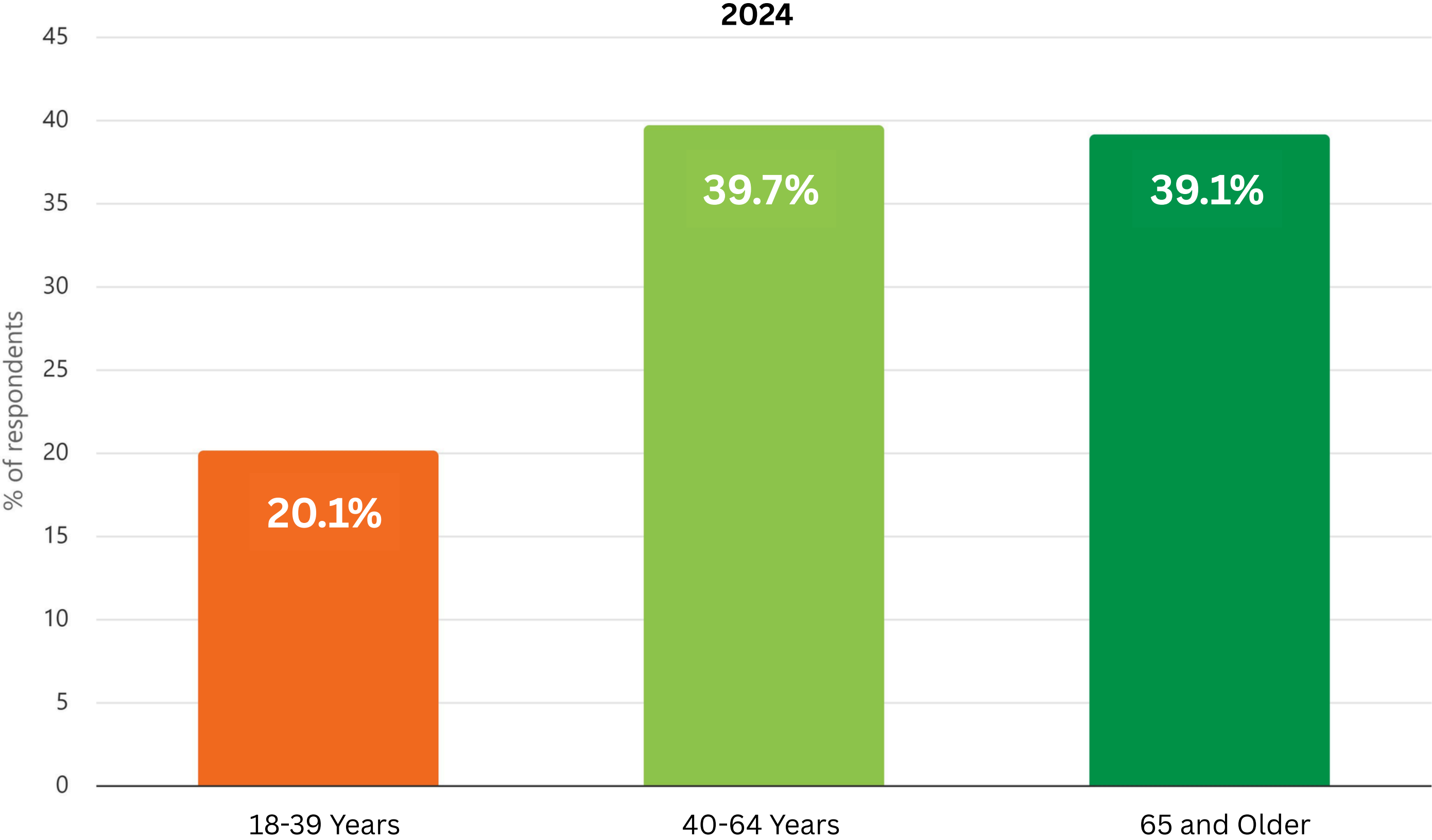

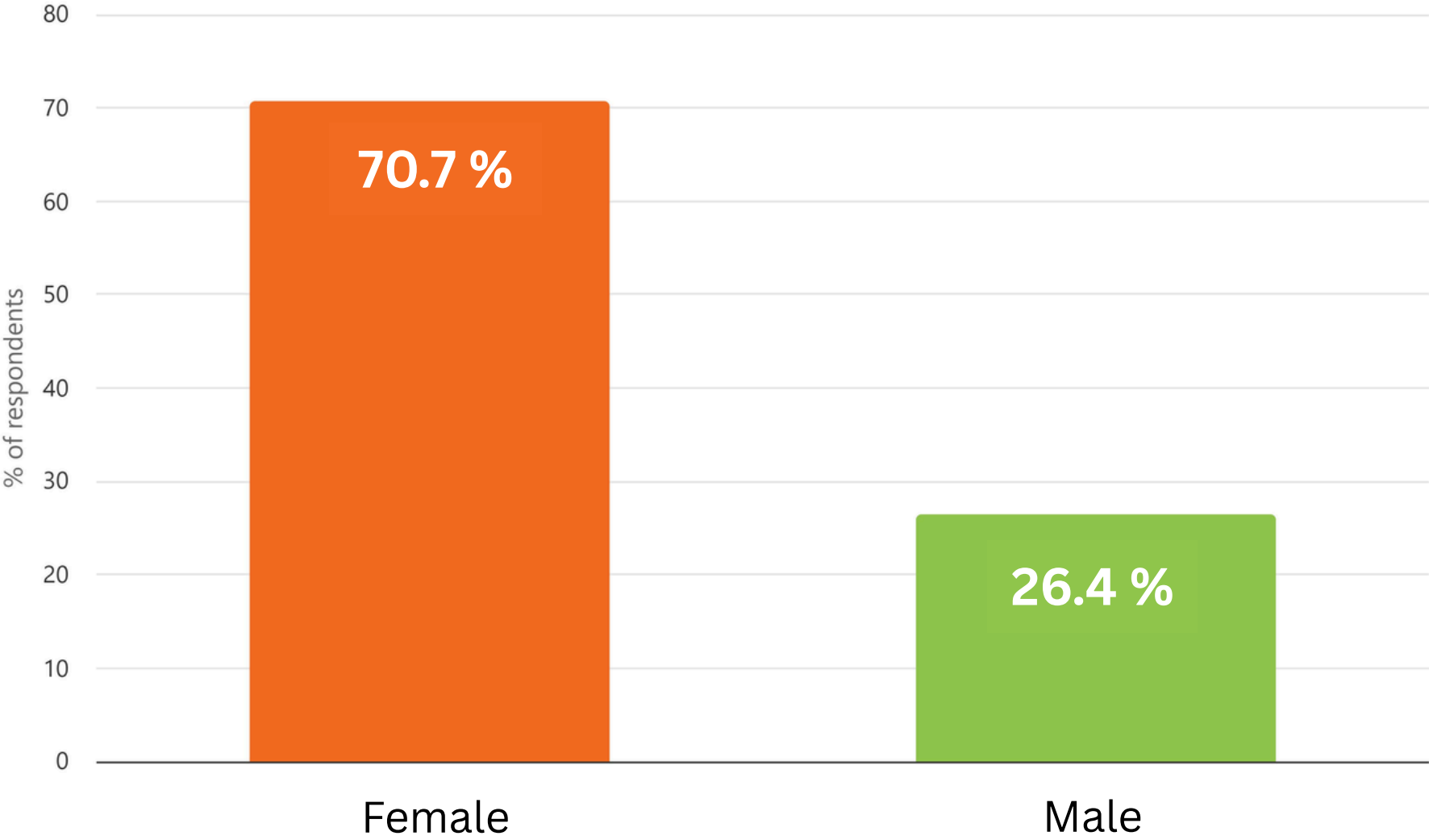

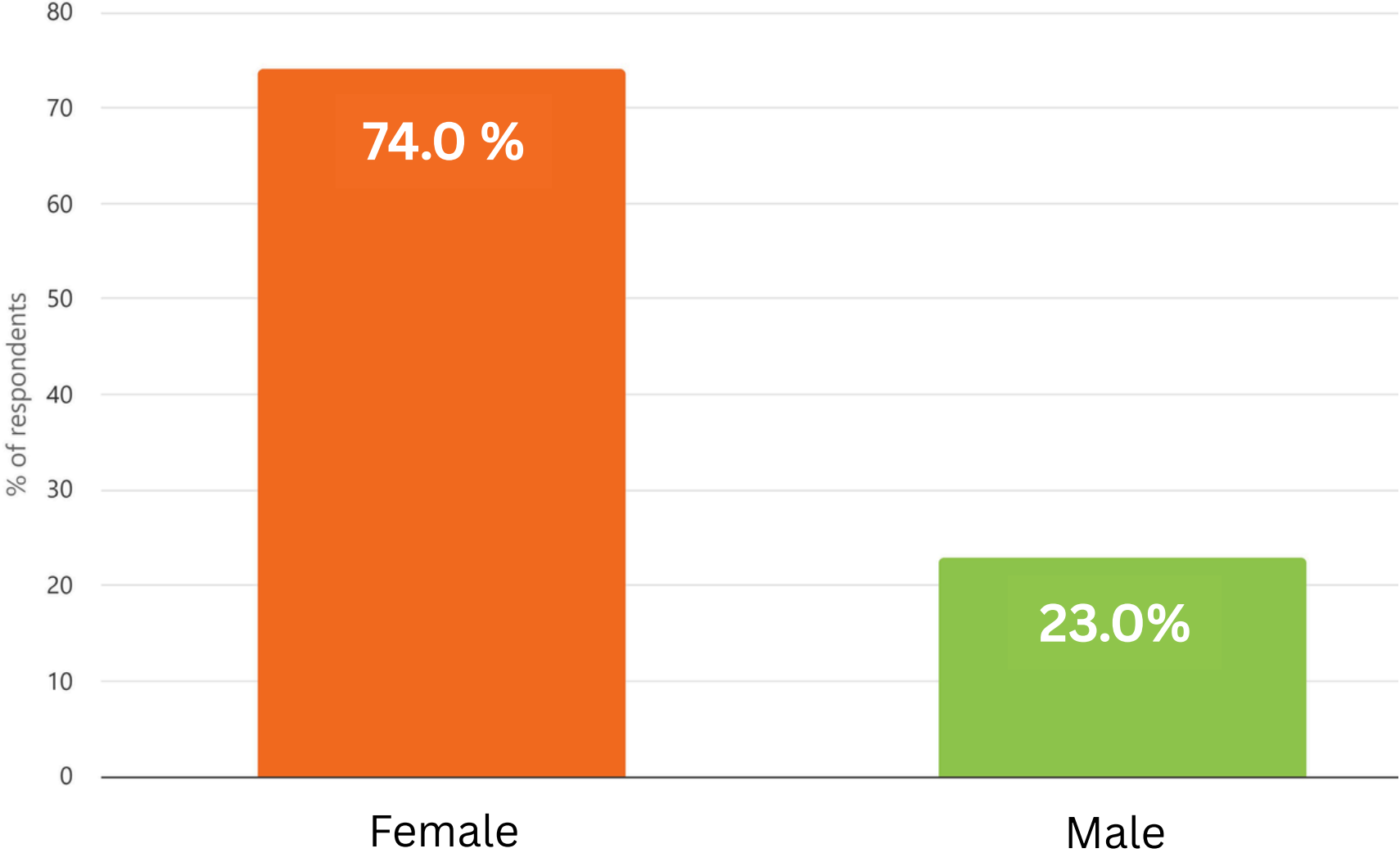


CHNA Surveys: Gender identity of respondents

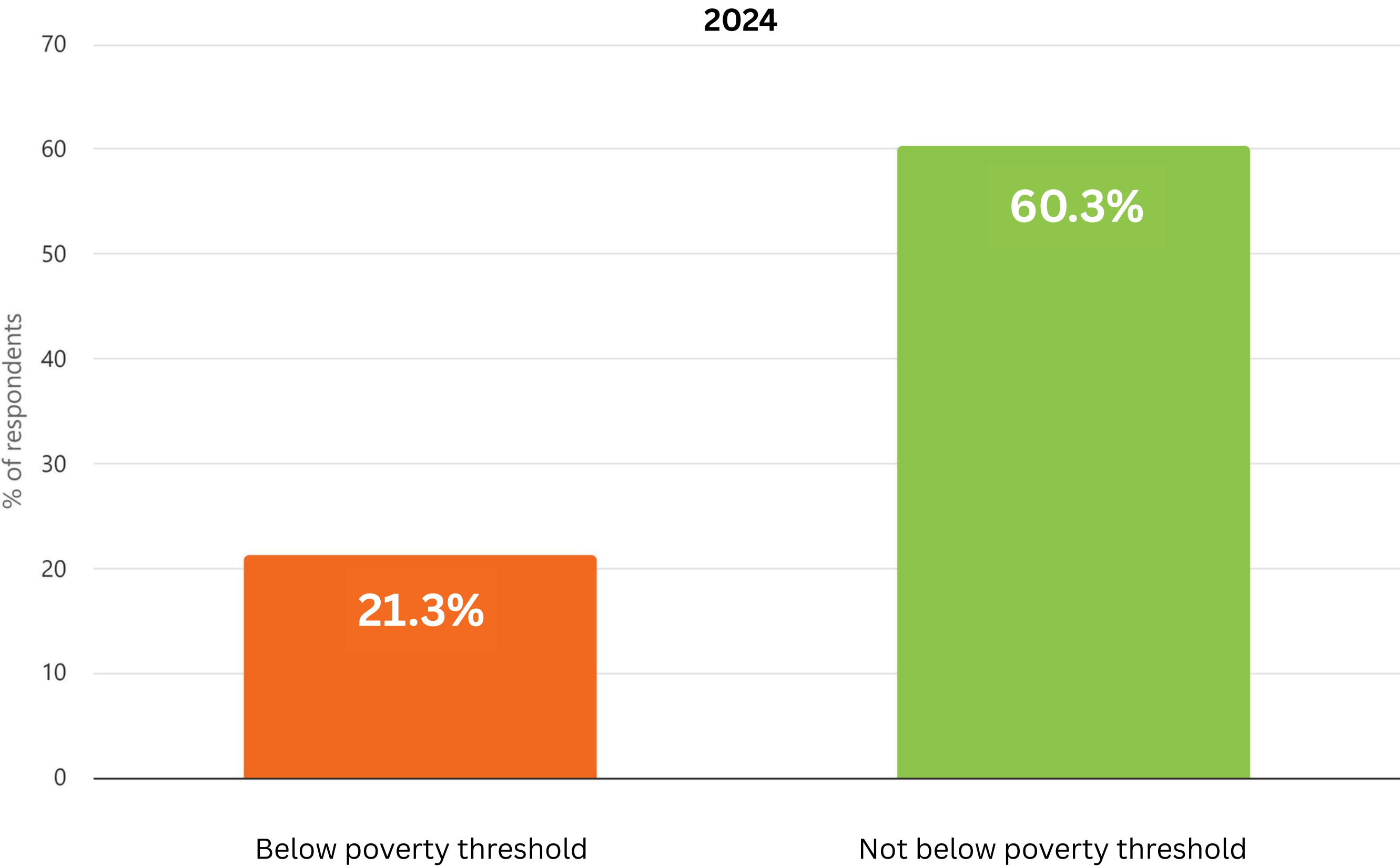

A note on secondary data



You may notice that some of the numbers presented differ from what was seen in earlier presentations. Why?

- Public health data are not static. Agencies like the CDC continue to receive new reports, verify information and improve analytic methods even after data are first published.
- When this happens, previously reported numbers may be updated.
- These updates are normal and reflect stronger, more complete information.
- Updates usually **do not** change the actual severity of public health issues.

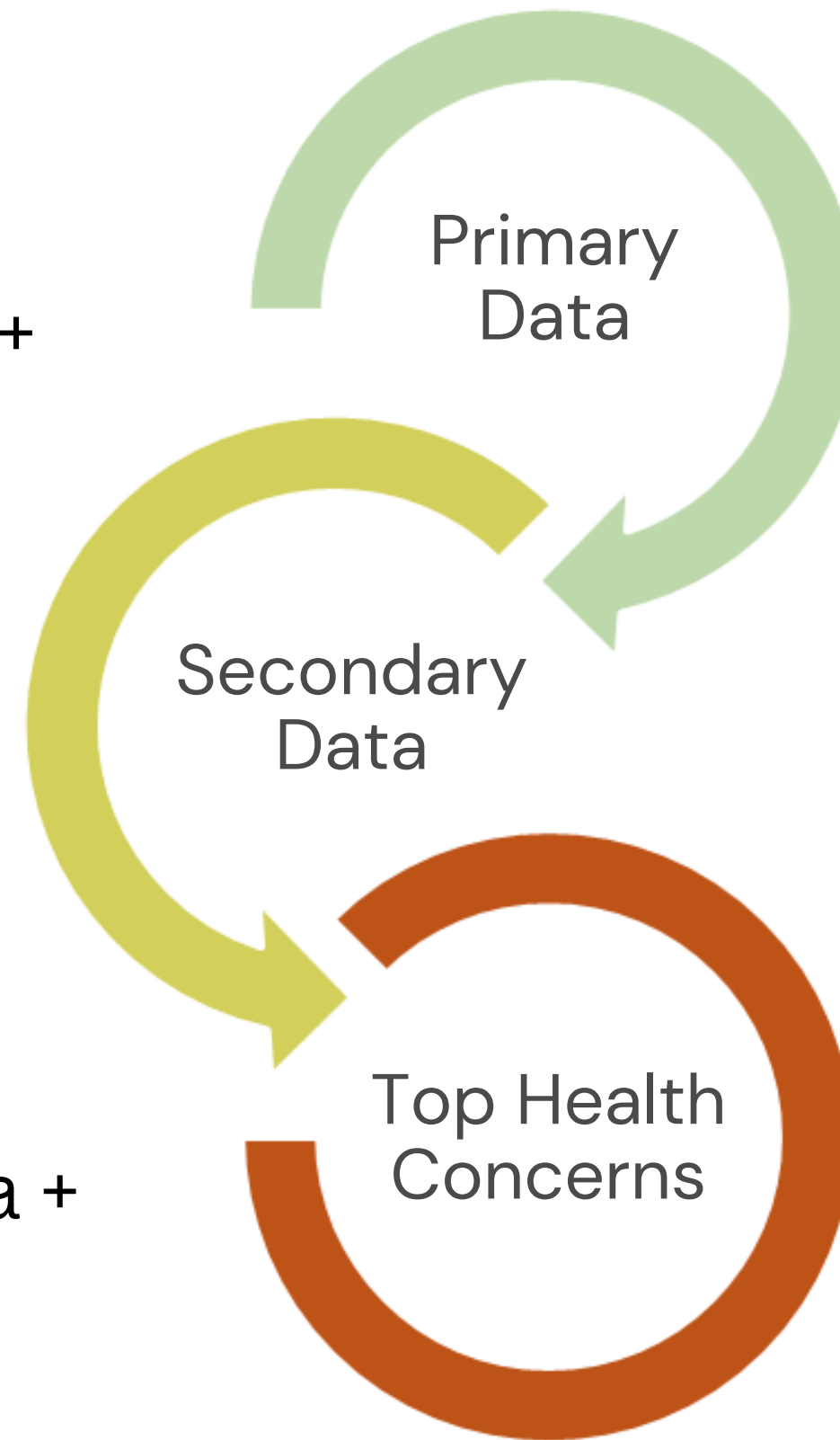

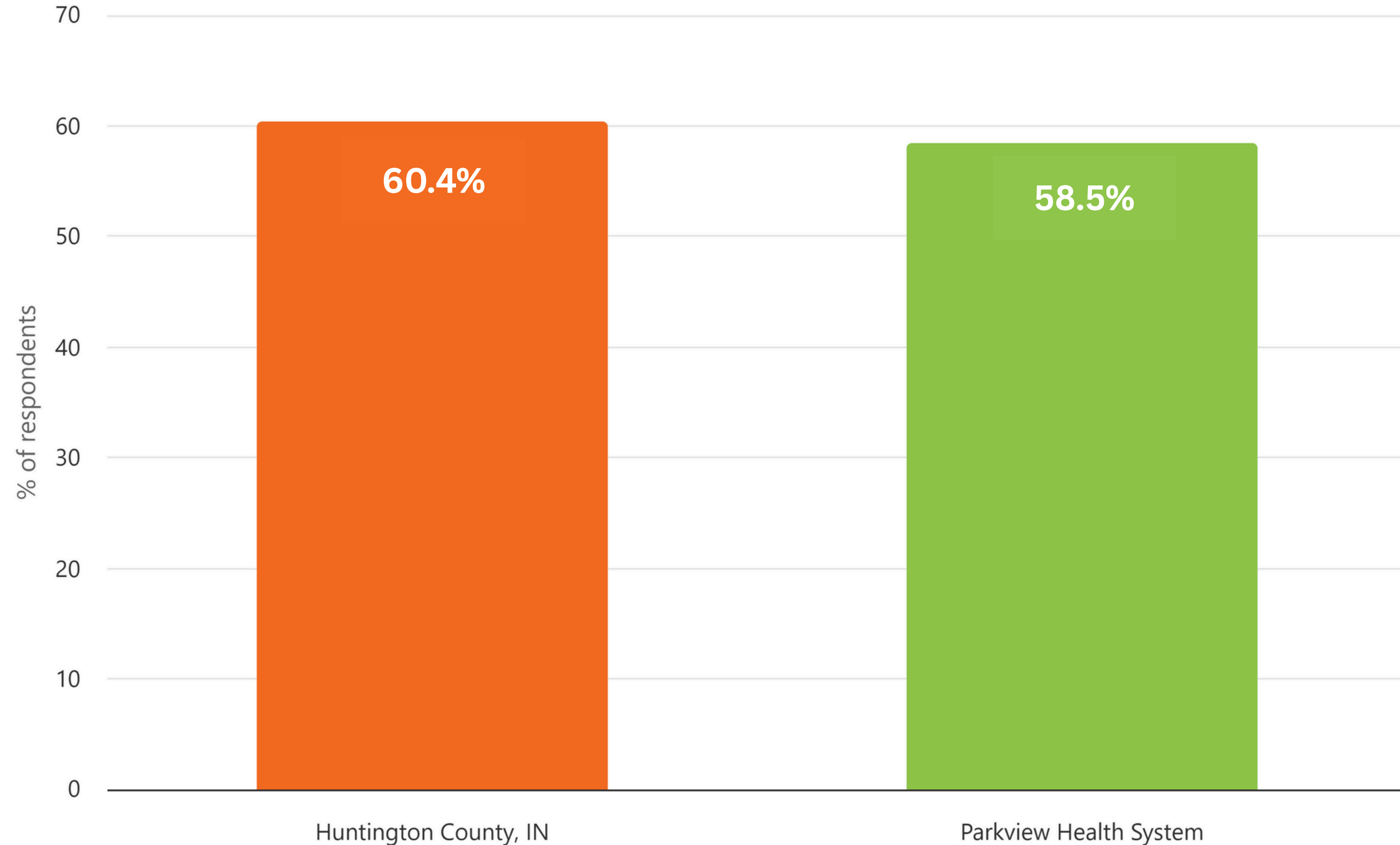

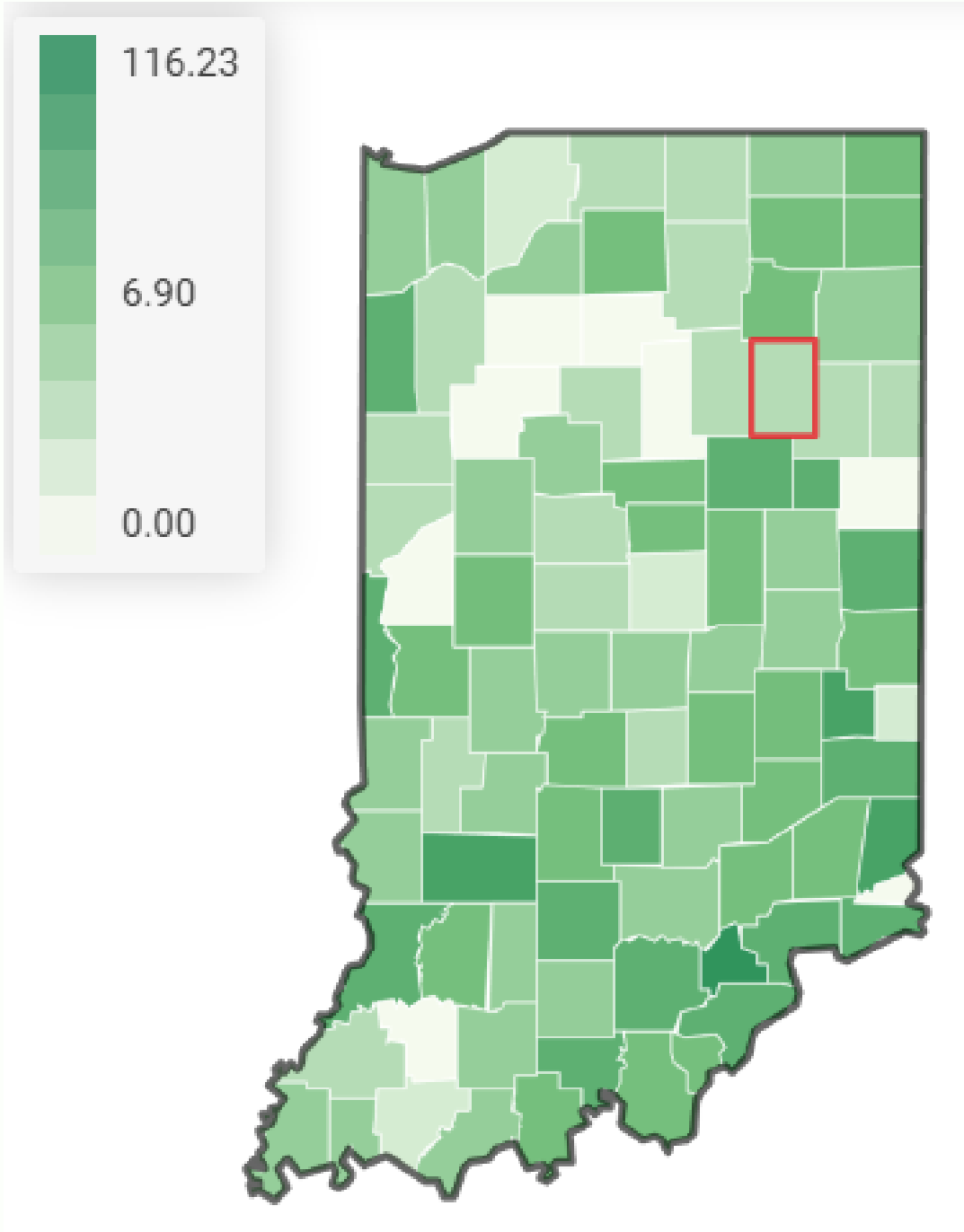

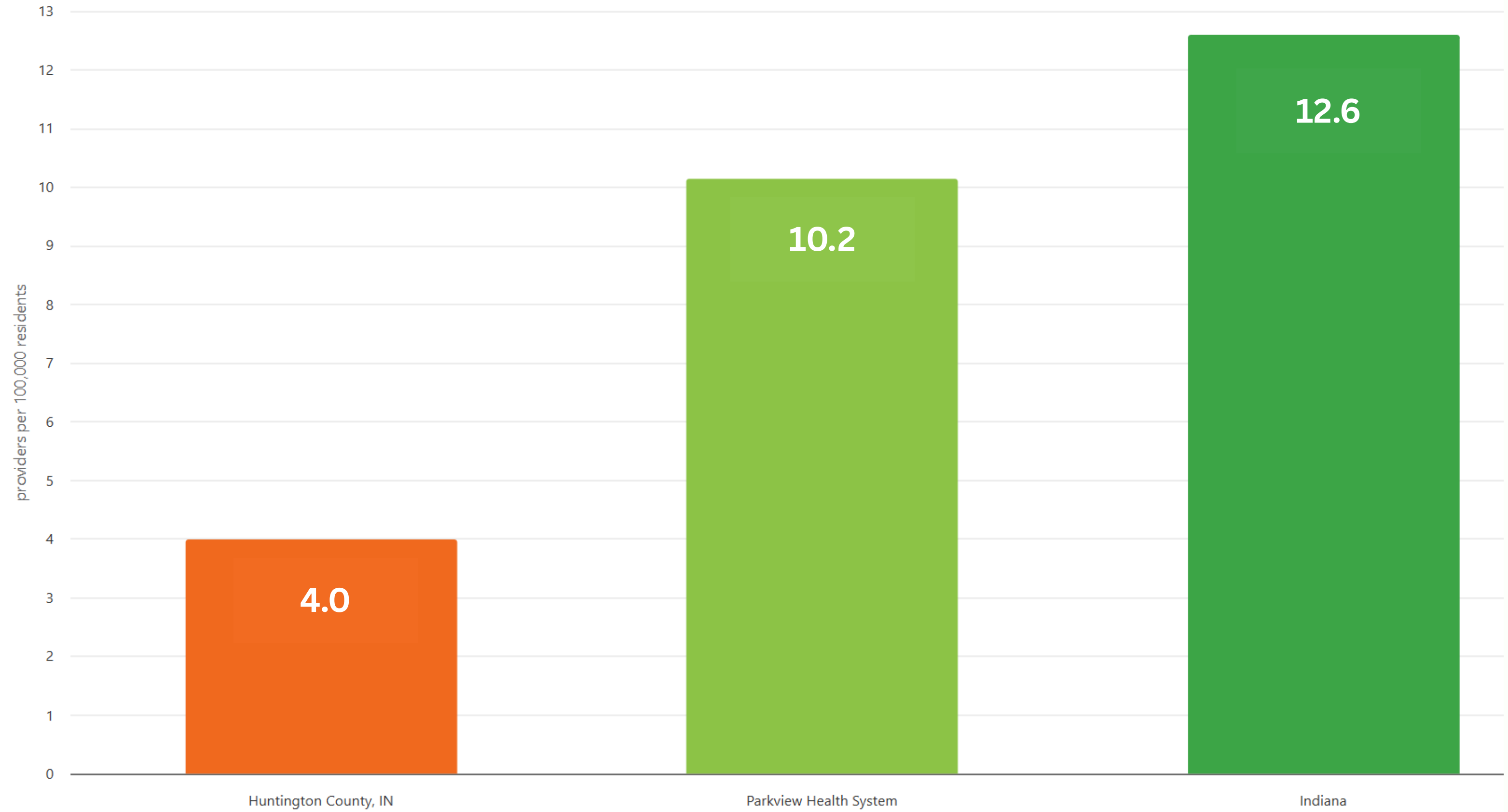

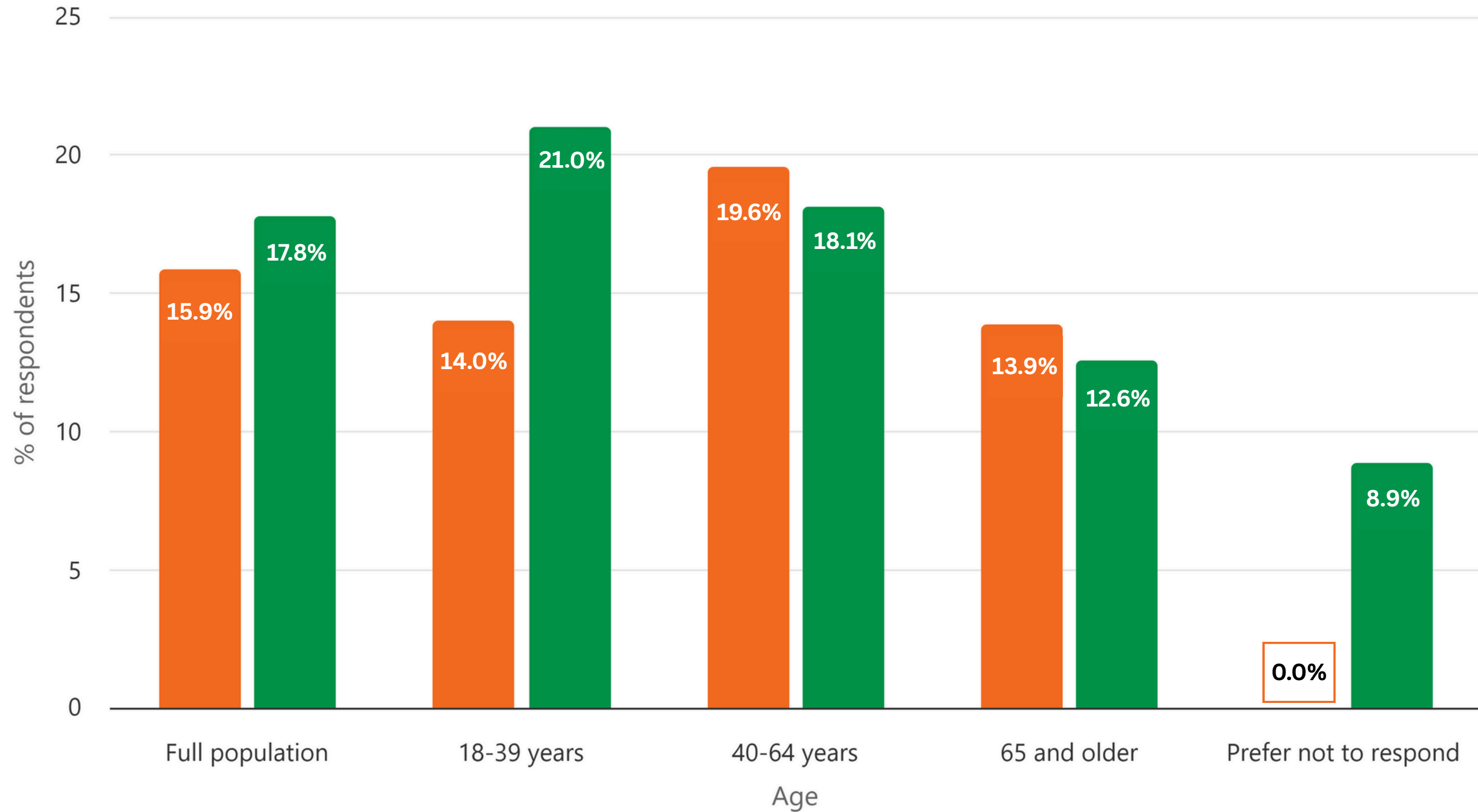

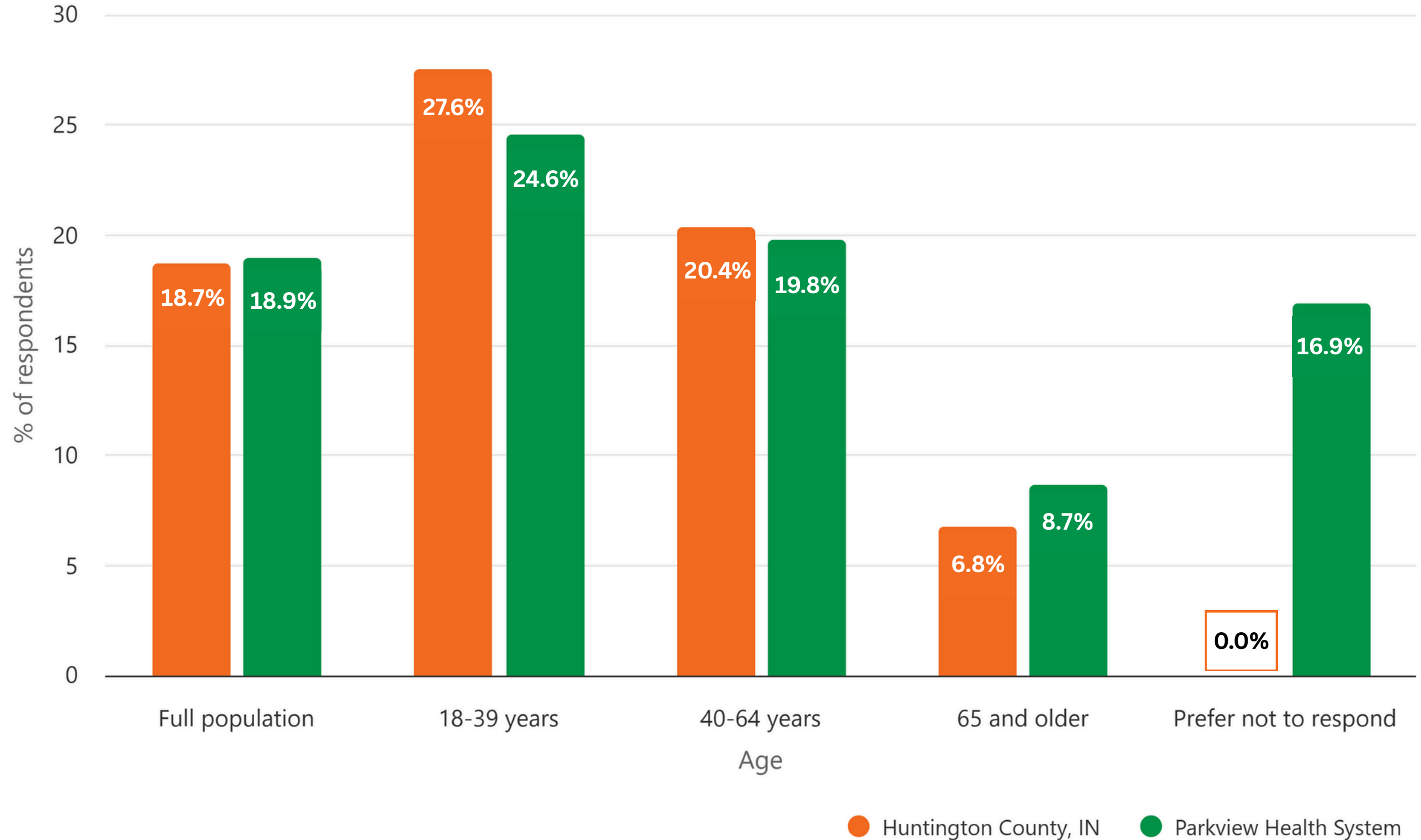

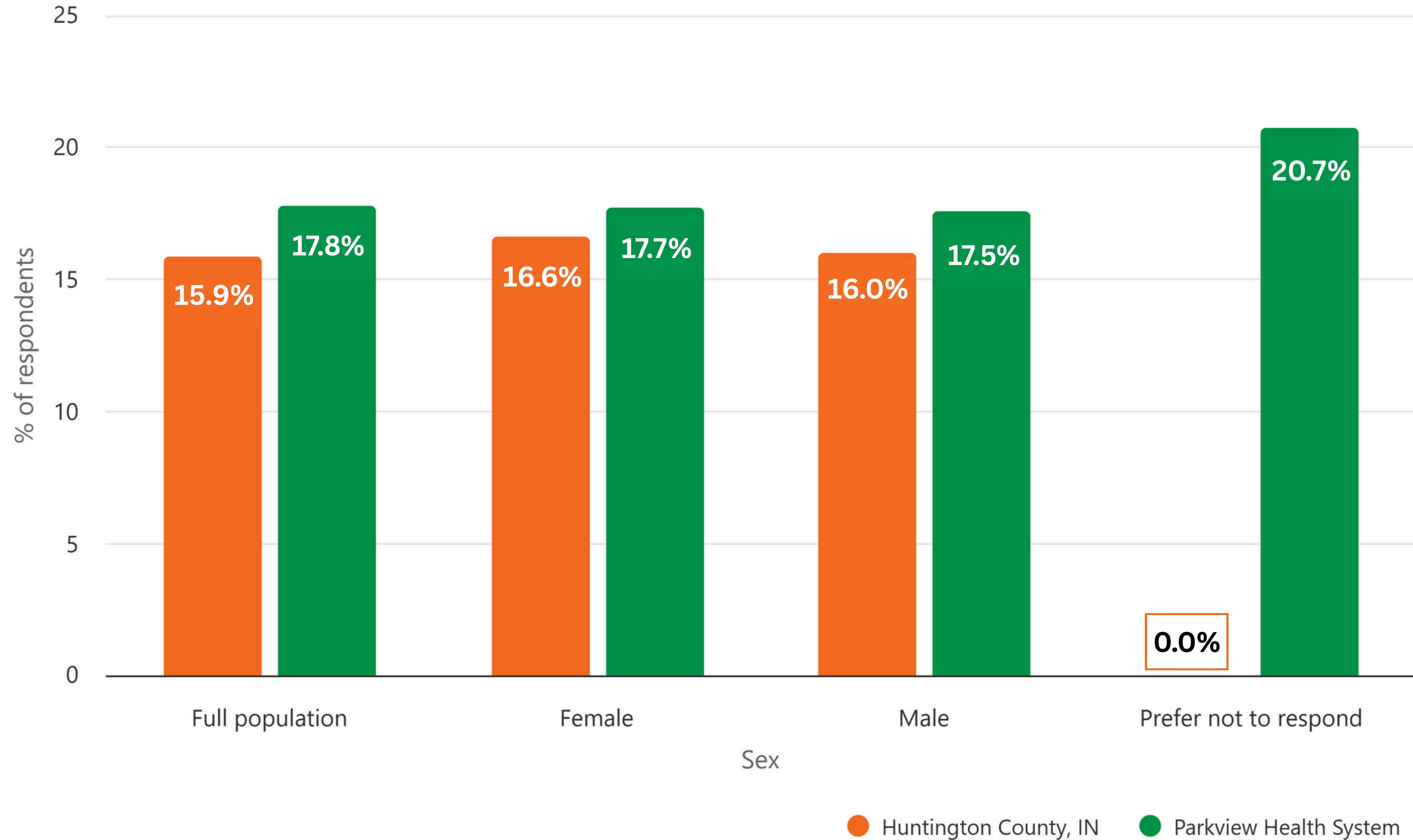

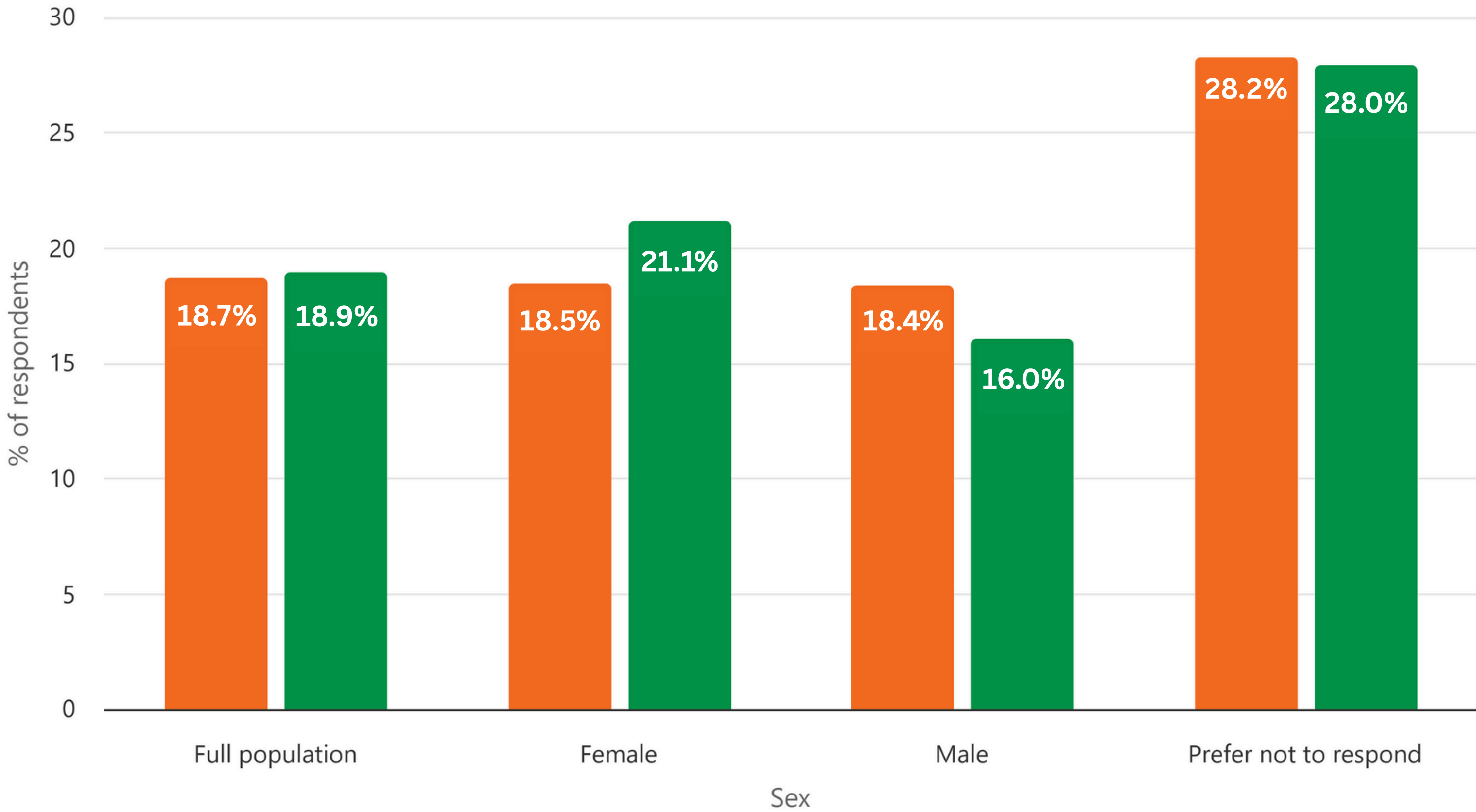

Summary of Community Survey Data and Local Health Statistics

Access to Mental Health Care & Addiction Services

- The number of **mental health providers** per 100,000 residents is **improving** in Huntington County, though it is **lower** than the number per capita across the Parkview Health service area and Indiana.
 - Compared to Indiana, Huntington County has **fewer** **mental health and substance use treatment facilities, psychiatry physicians and opioid treatment providers** per capita.
 - Several **community survey respondents** reported that they were not sure where to get mental health services (**15.9%**) or have had a problem getting mental health or addiction services (**18.7%**), and these numbers **varied by age and race/ethnicity**.

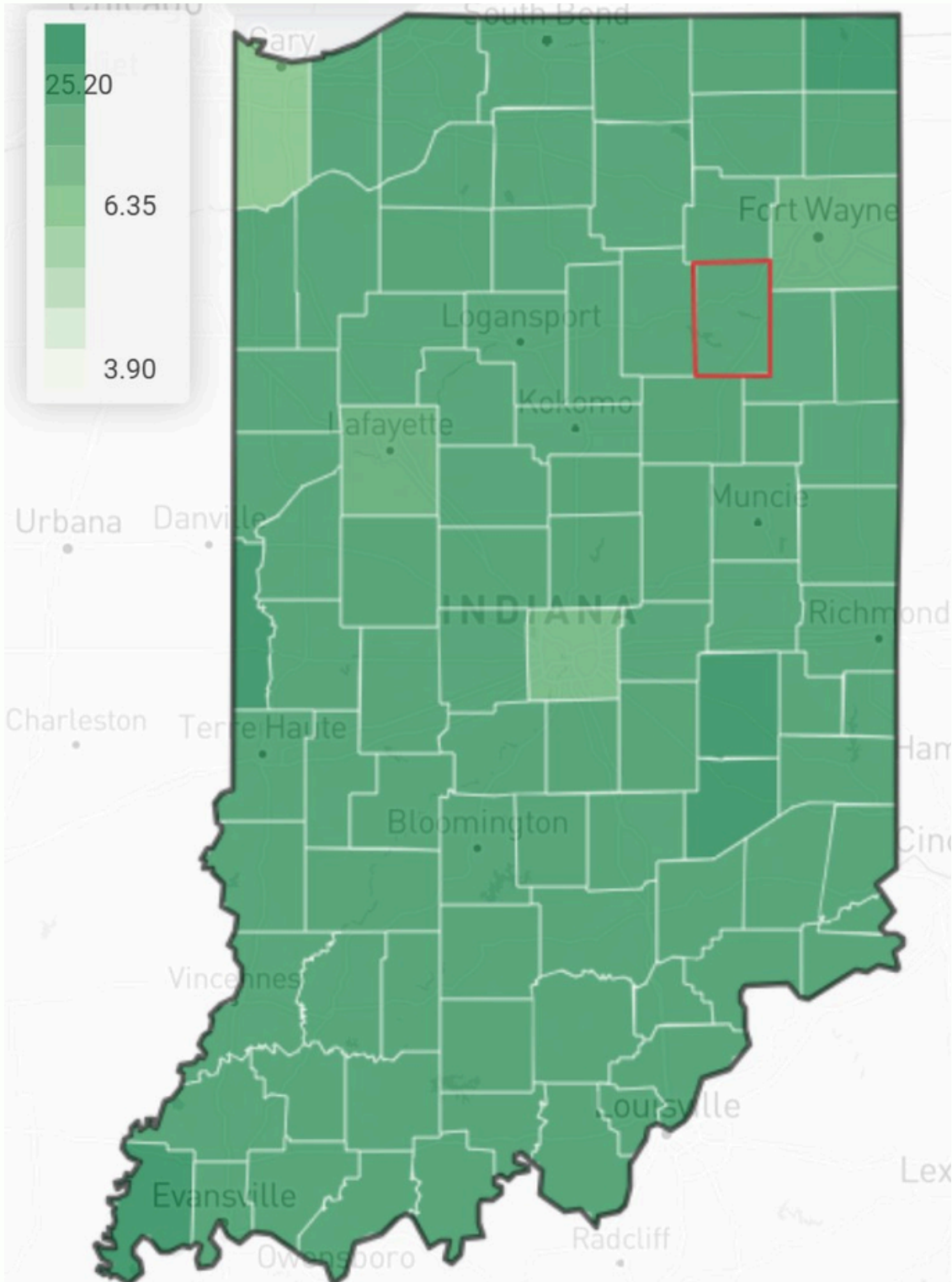

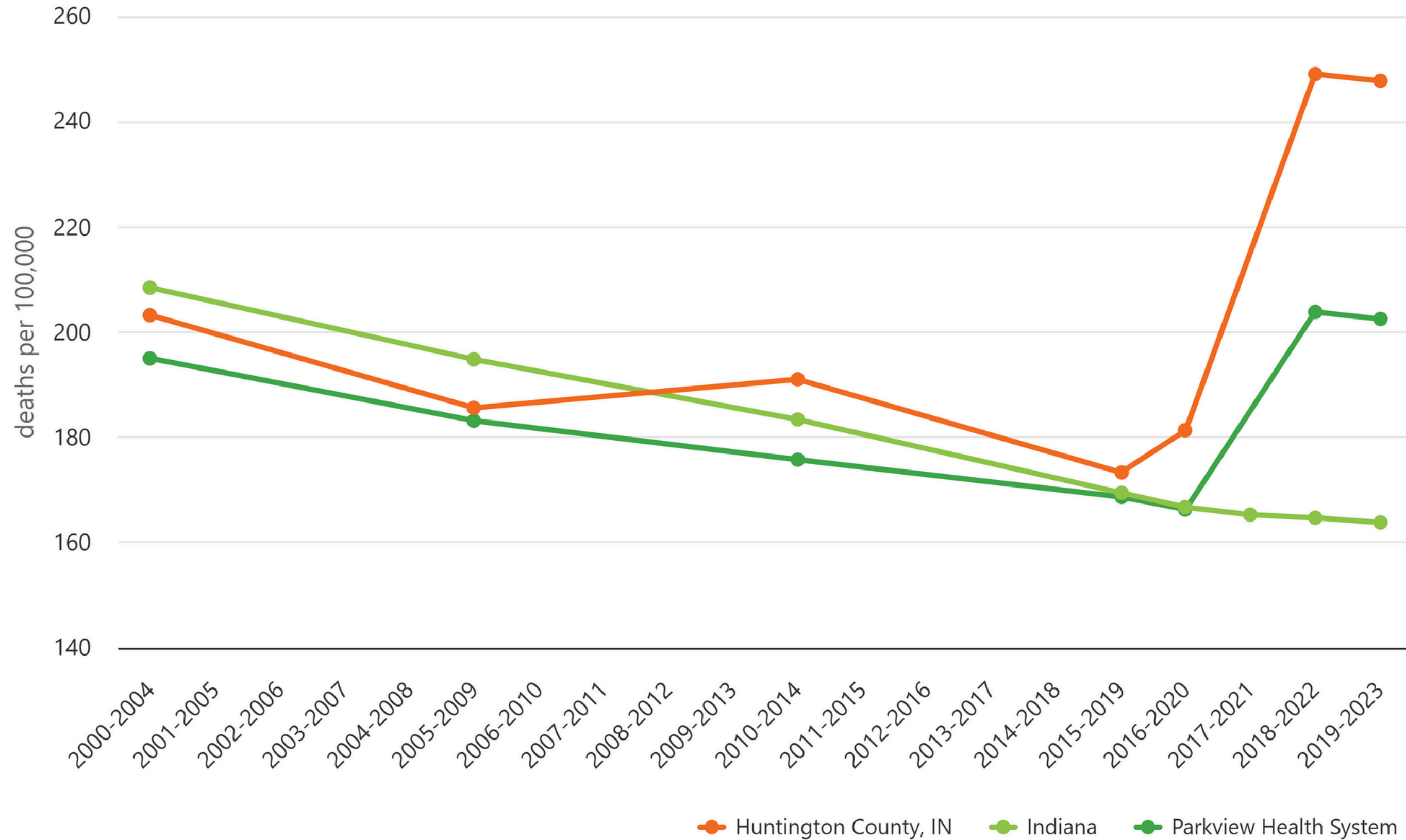

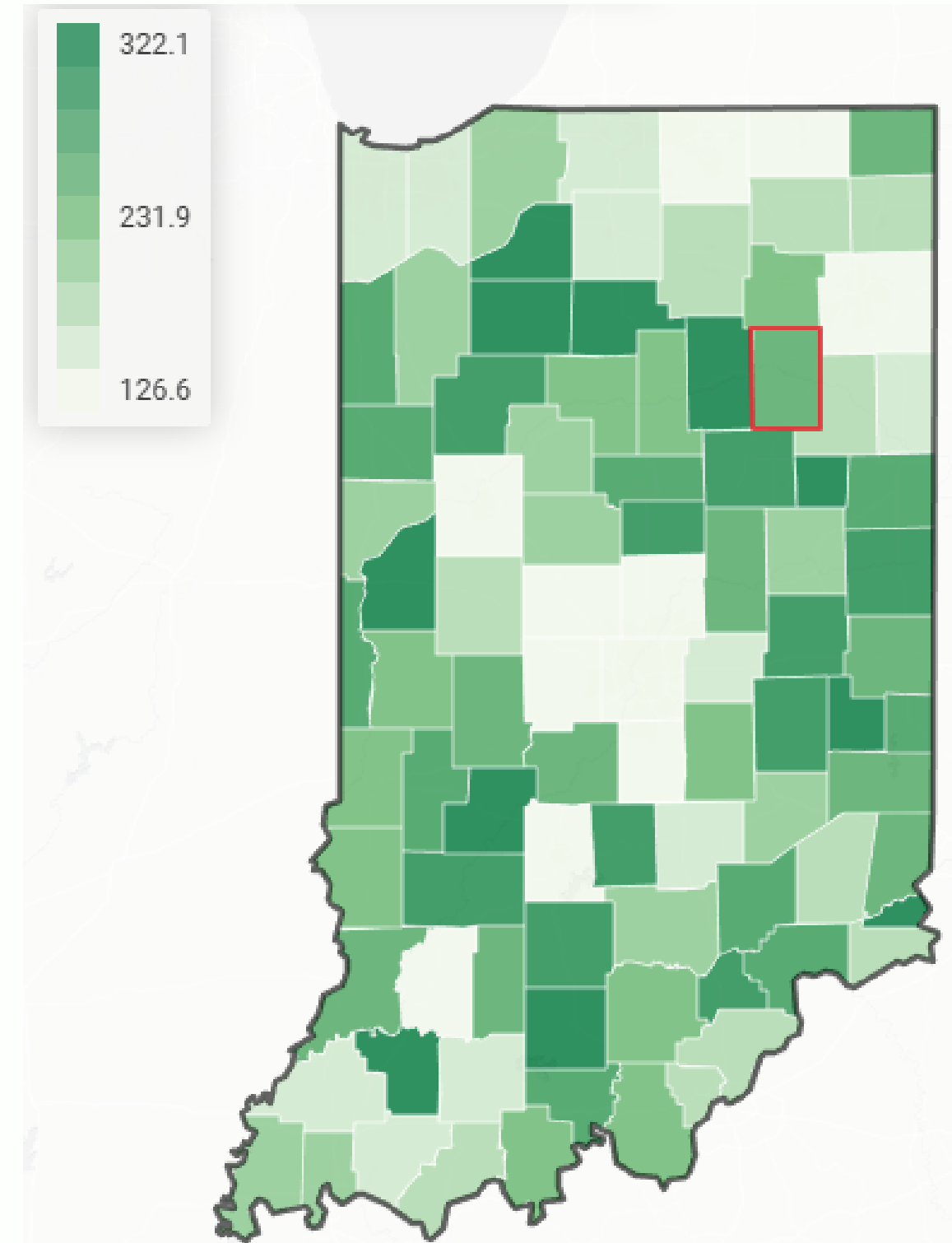

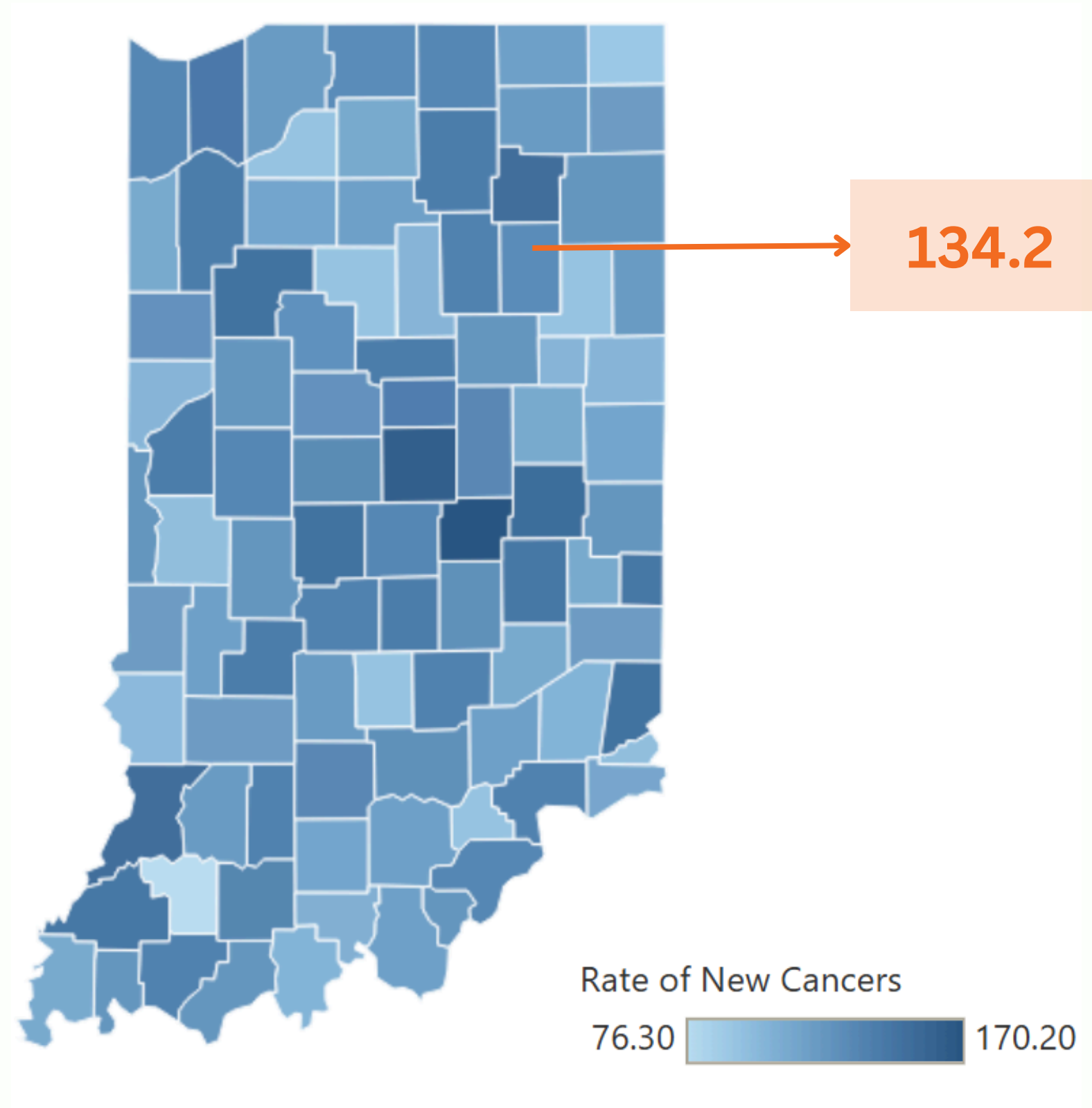

Breast Cancer Diagnosis Rate (Females Only)

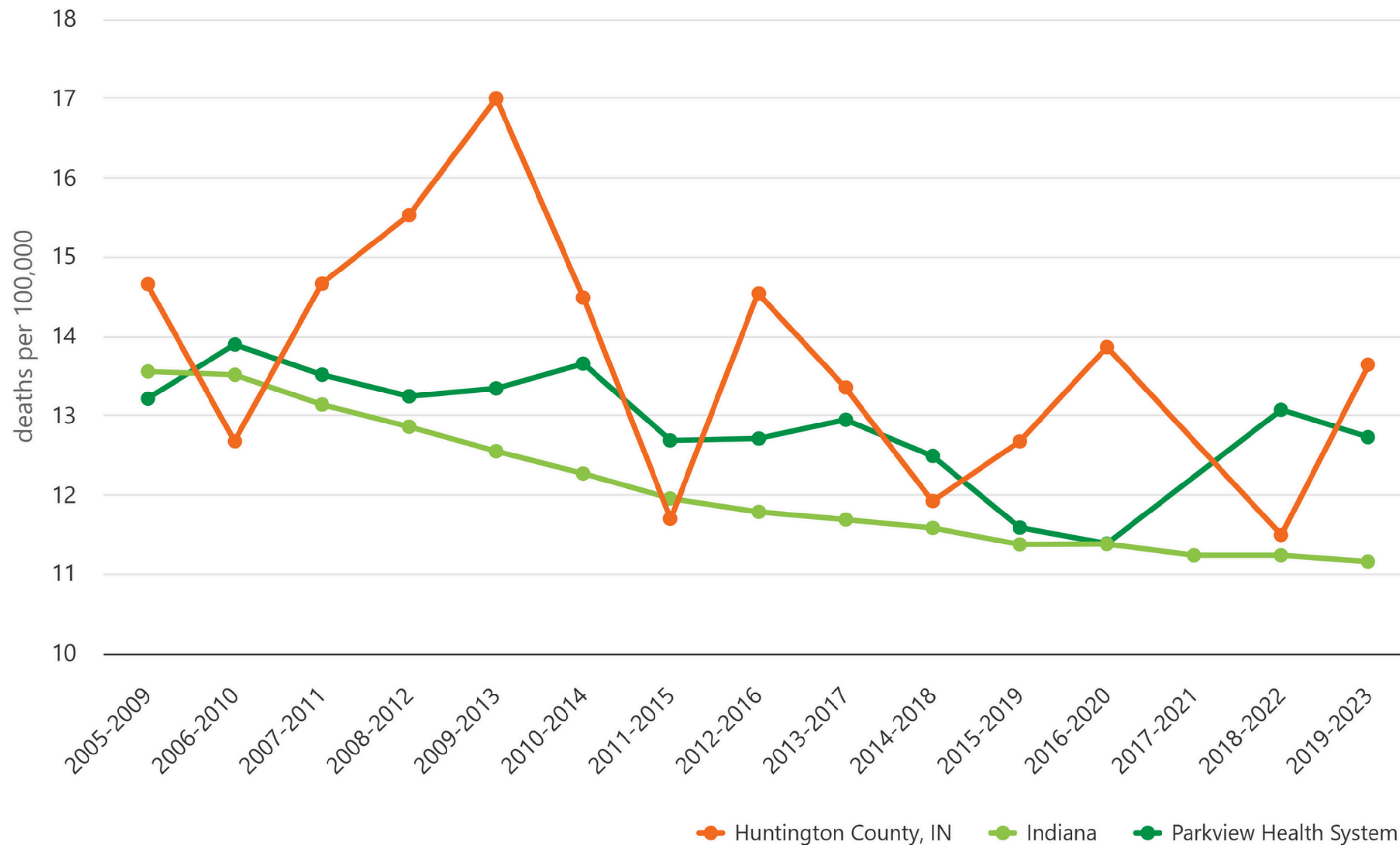

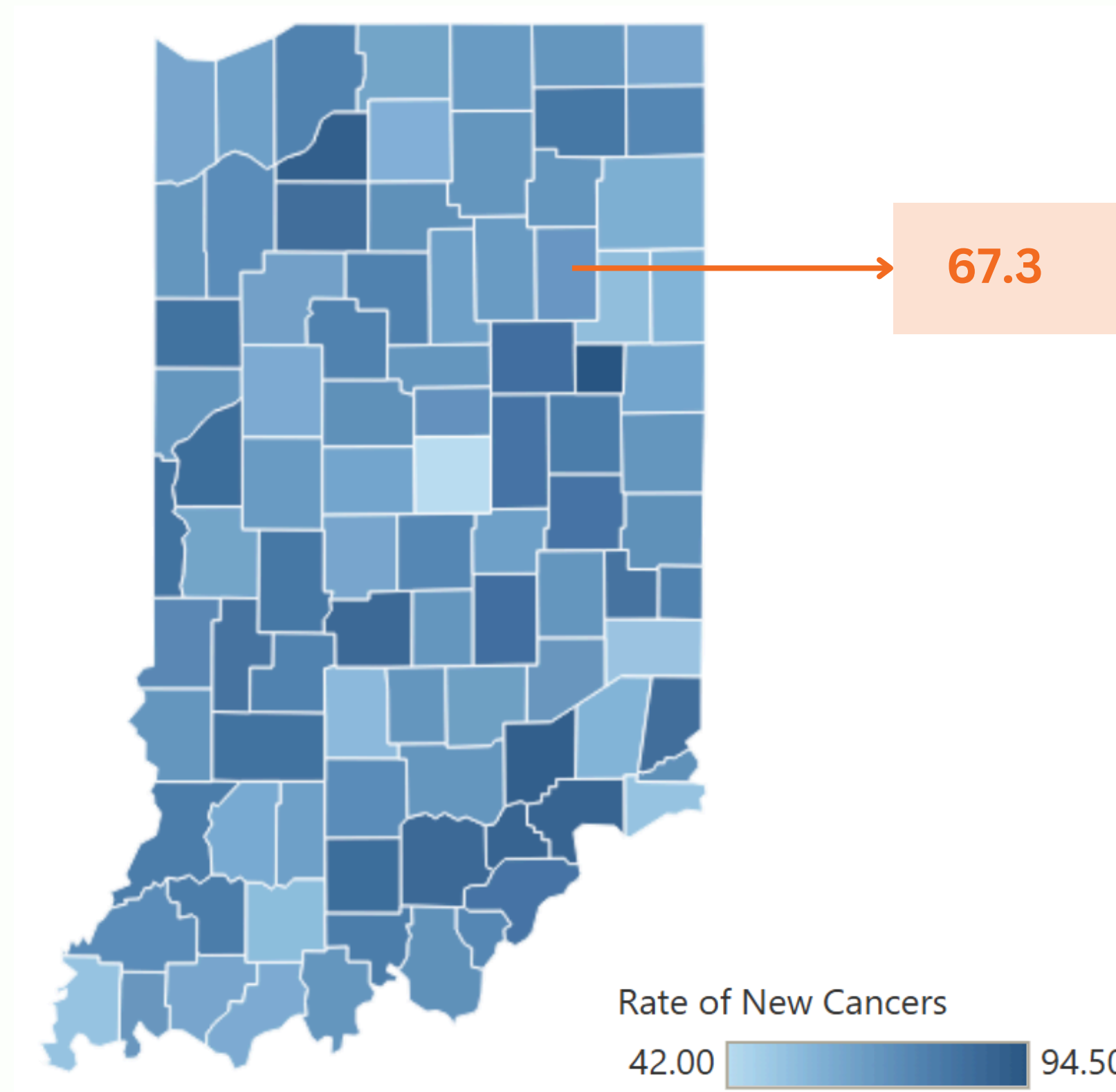

Lung Cancer Diagnosis Rate

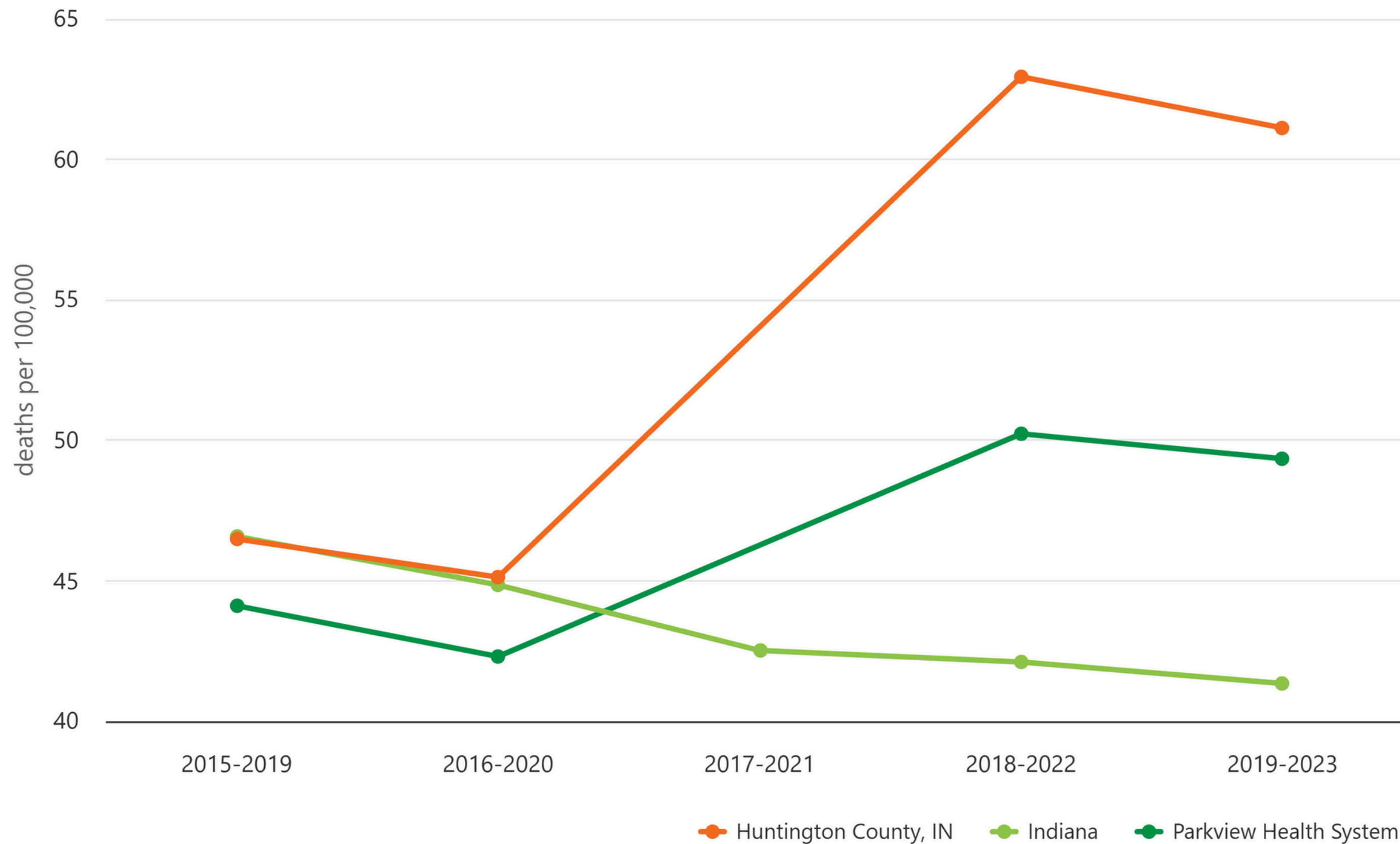

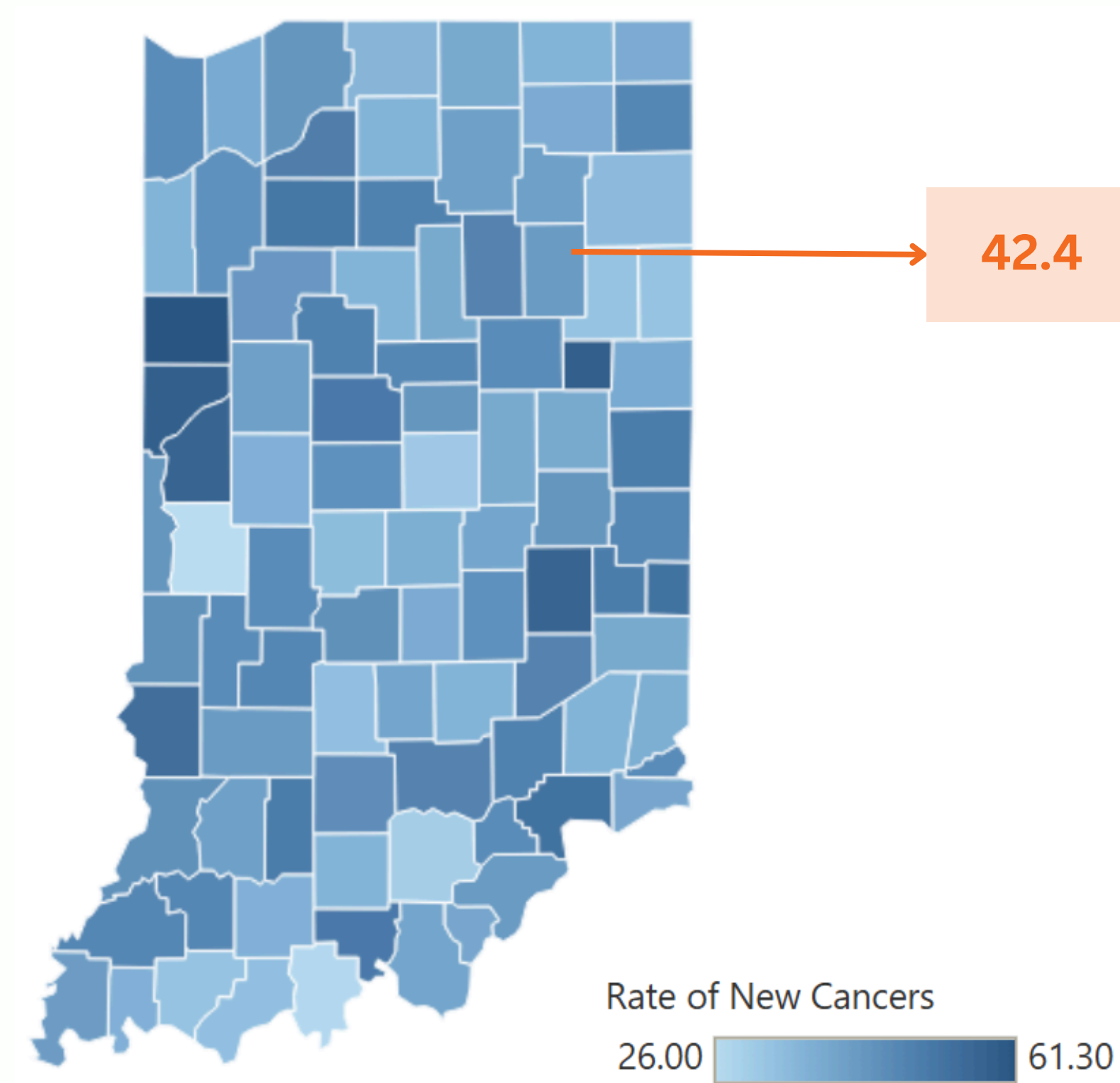

Colorectal Cancer Diagnosis Rate

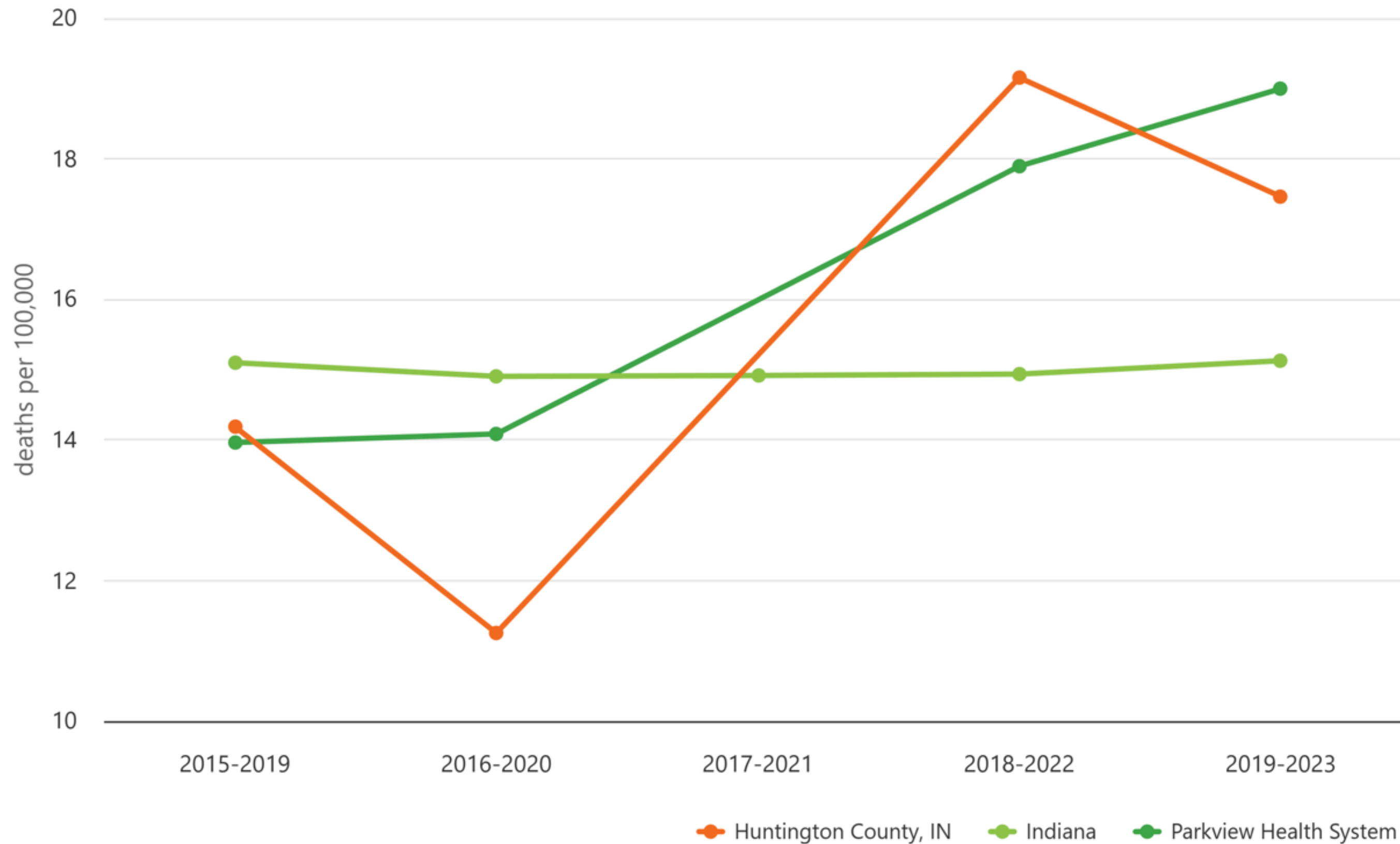

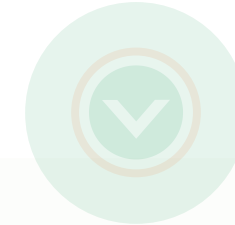
Cancers

- **Cancer diagnoses** and **cancer mortality** are **increasing** in Huntington County and are **higher** than the Parkview Health service area and the state average.
 - **Mortality rates** from several types of cancers (including breast, lung, trachea and bronchus and colorectal) are **higher** in Huntington County compared to Indiana as a whole, and are getting **worse over time**.

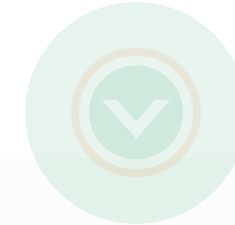
Diabetes

- The percentage of adults with **diabetes** in Huntington County is lower than in Indiana and the Parkview Health service area, but is **steadily increasing**.
 - **Diabetes mortality rates** are **decreasing** in Huntington County, but remain higher than in Indiana (**32.2** vs. 28.5 deaths per 100,000 residents).
 - The percentage of **Medicare beneficiaries age 65+** diagnosed with diabetes is holding steady at **28%** but is still higher than the Parkview Health service area and Indiana.

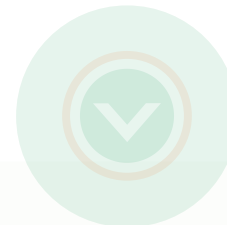

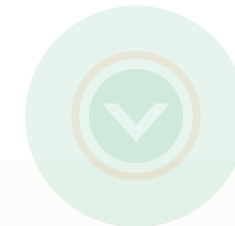

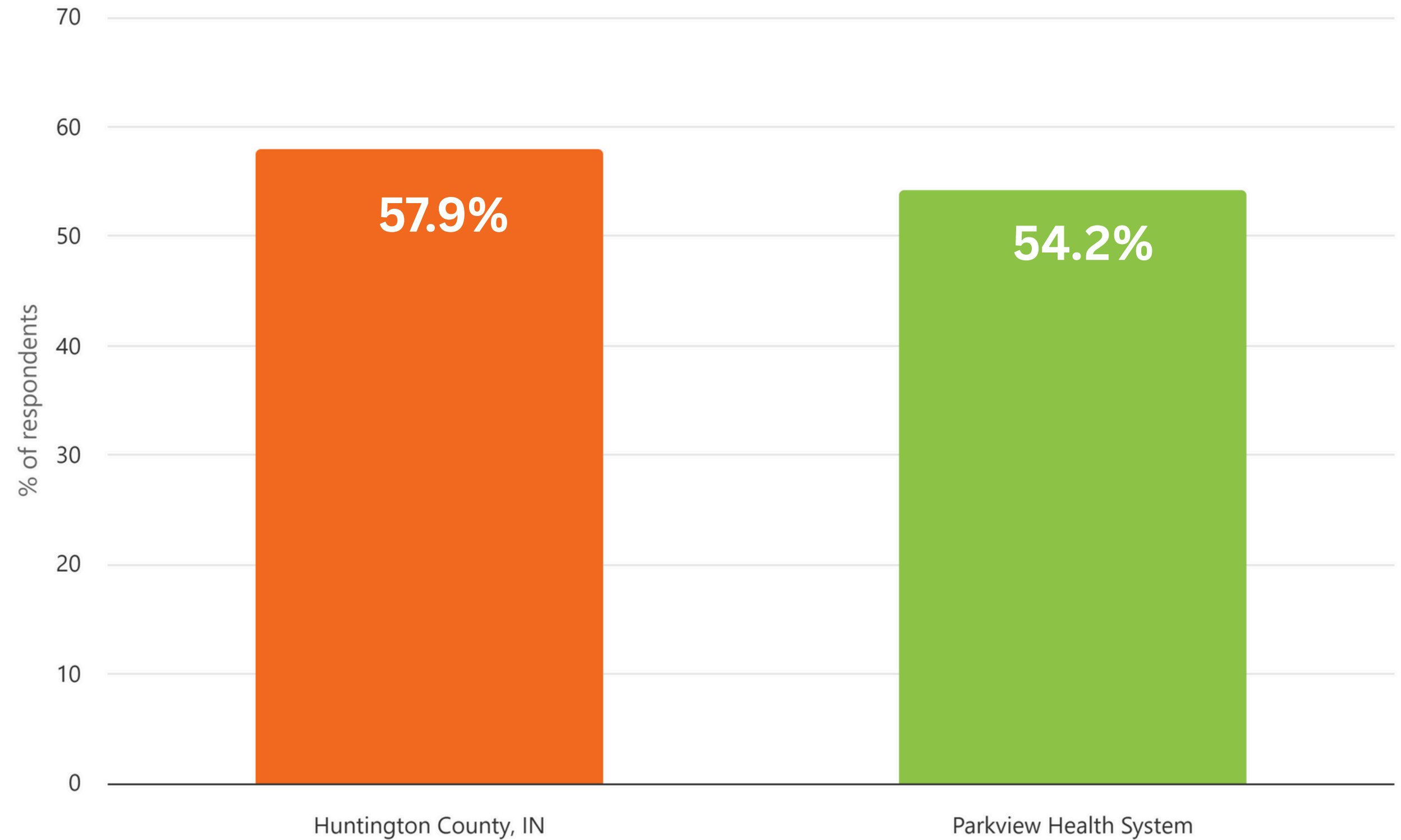

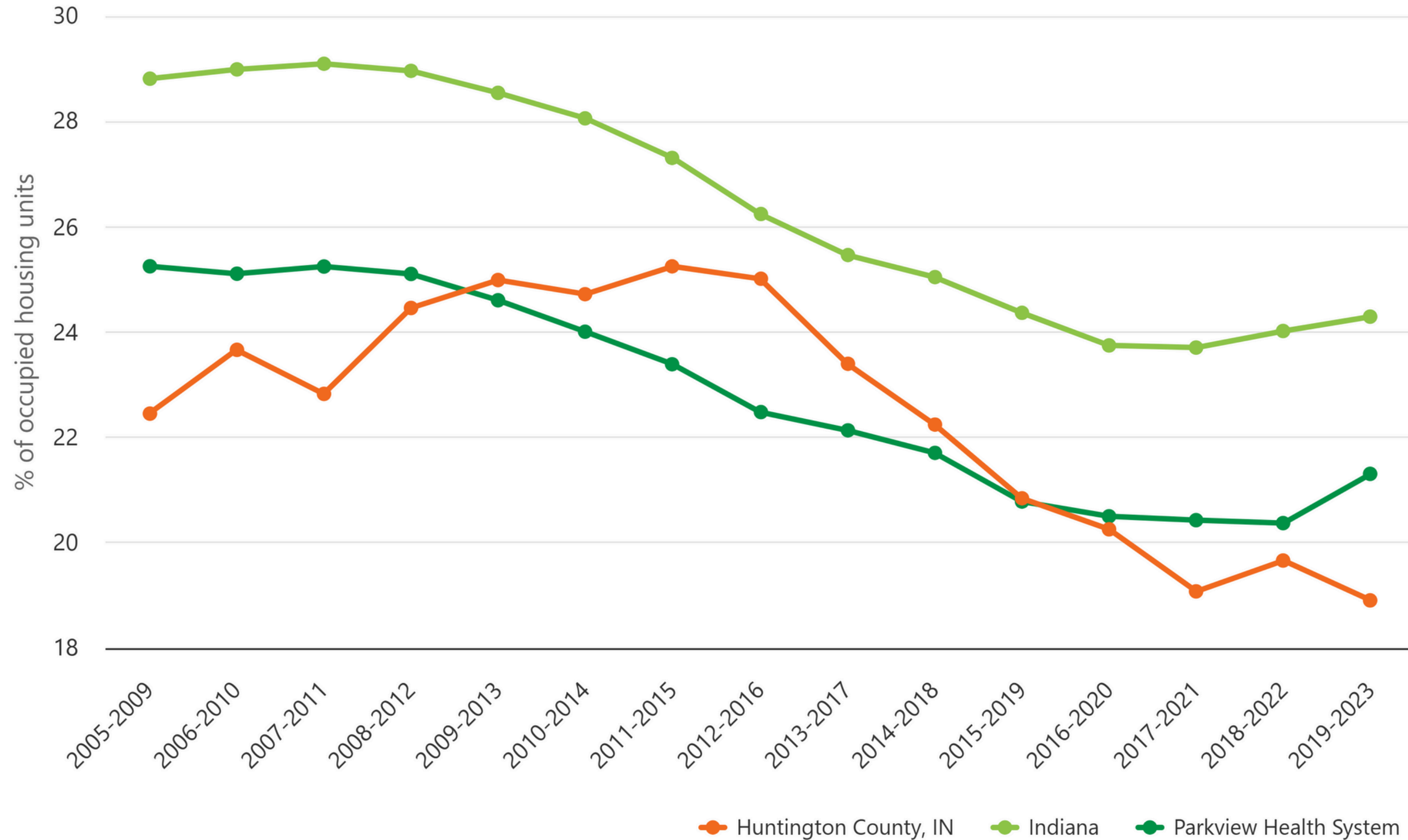

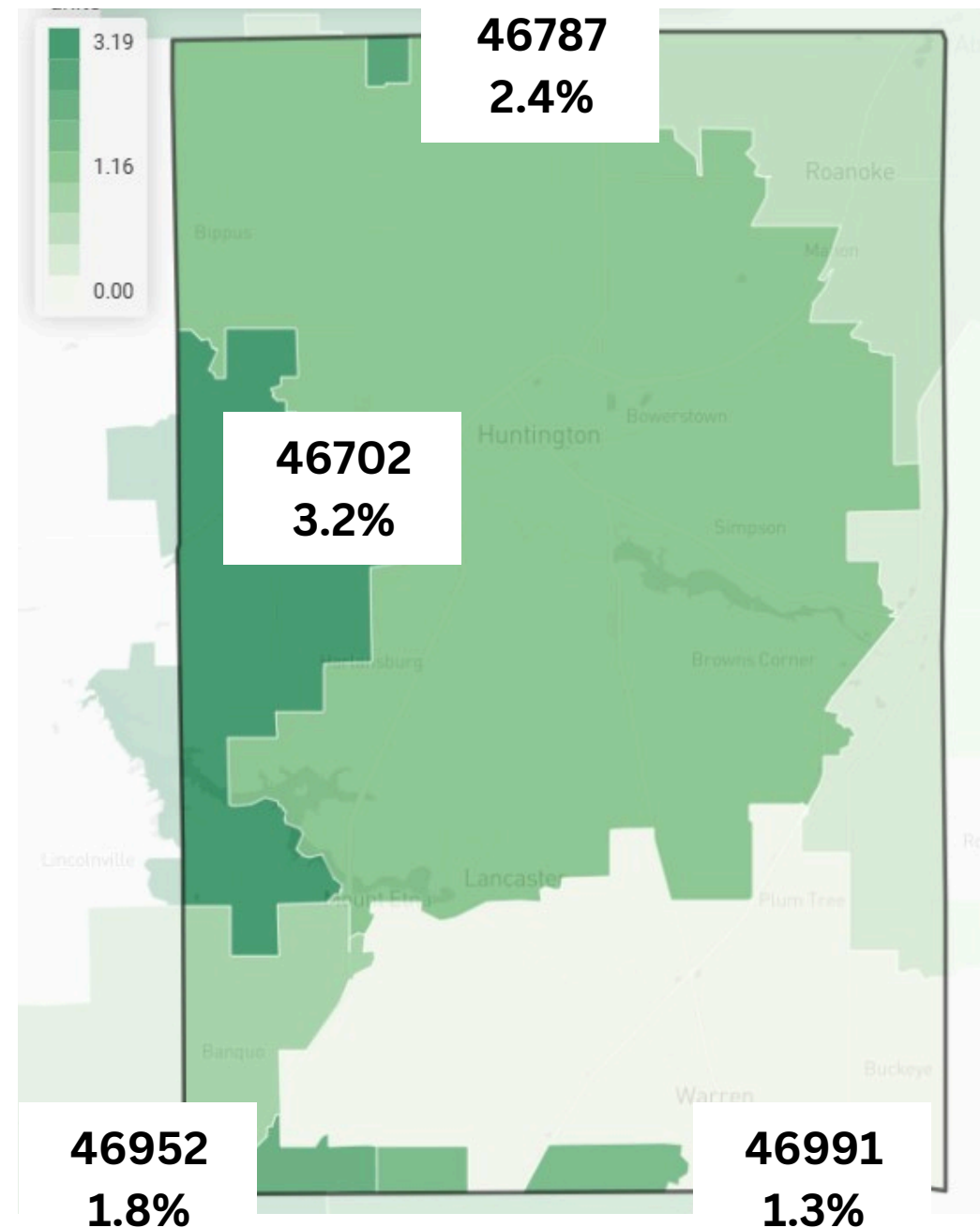

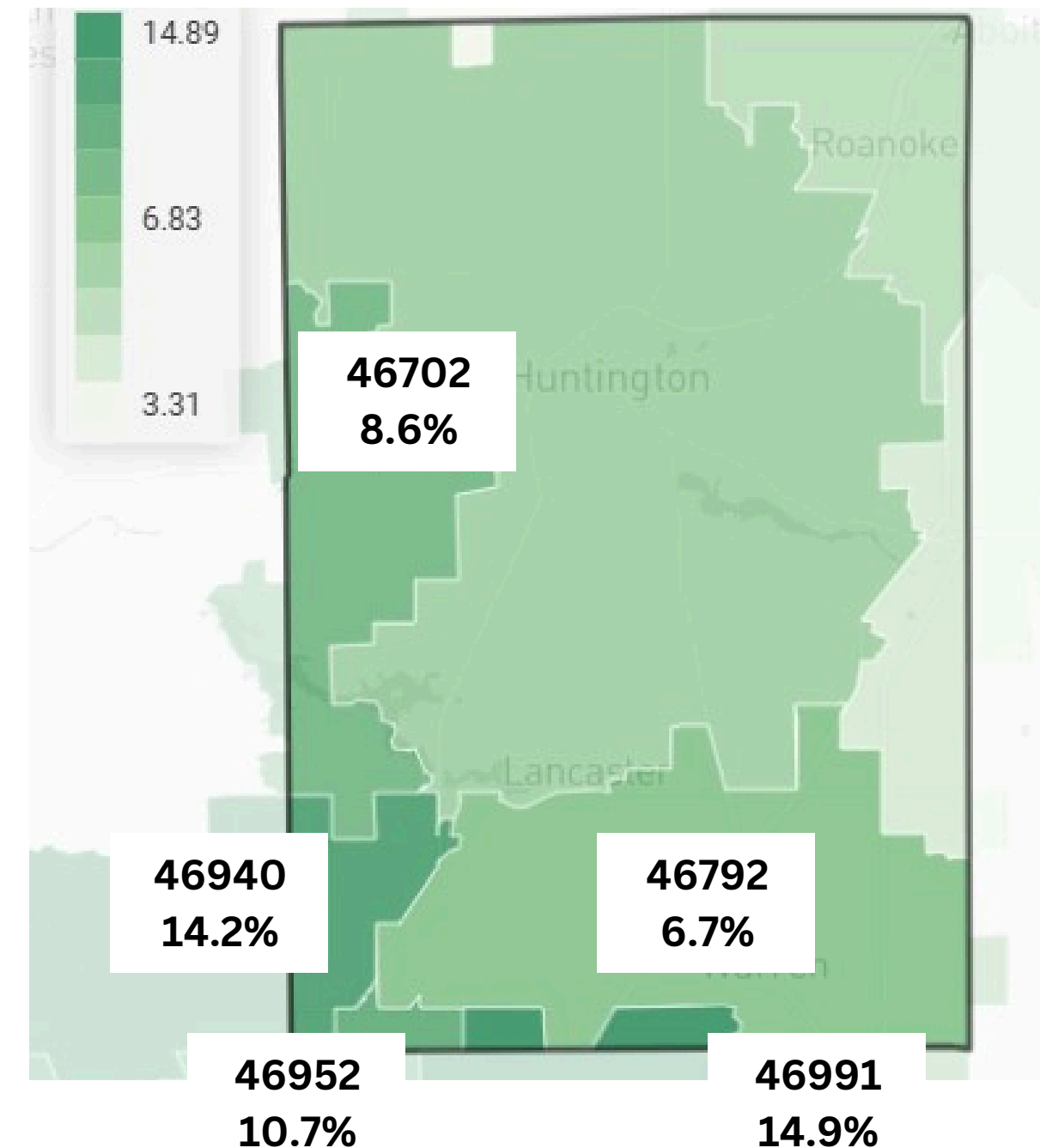


Crowded & Vacant Housing

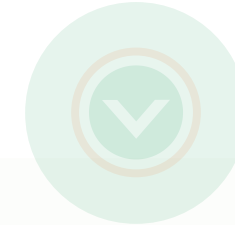
Housing Affordability

- Housing affordability is **improving** over time, though **18.9%** of Huntington County residents spend more than **30%** of their income on housing costs.
 - Zip codes of most concern for housing cost burden are **46702, 46770, 46787, 46952** and **46991**.
 - While the number of **vacant housing** units is **improving** in Huntington County, **crowded housing** is getting **worse** over time. However, both vacant and crowded housing rates in Huntington County are **below** the state average.

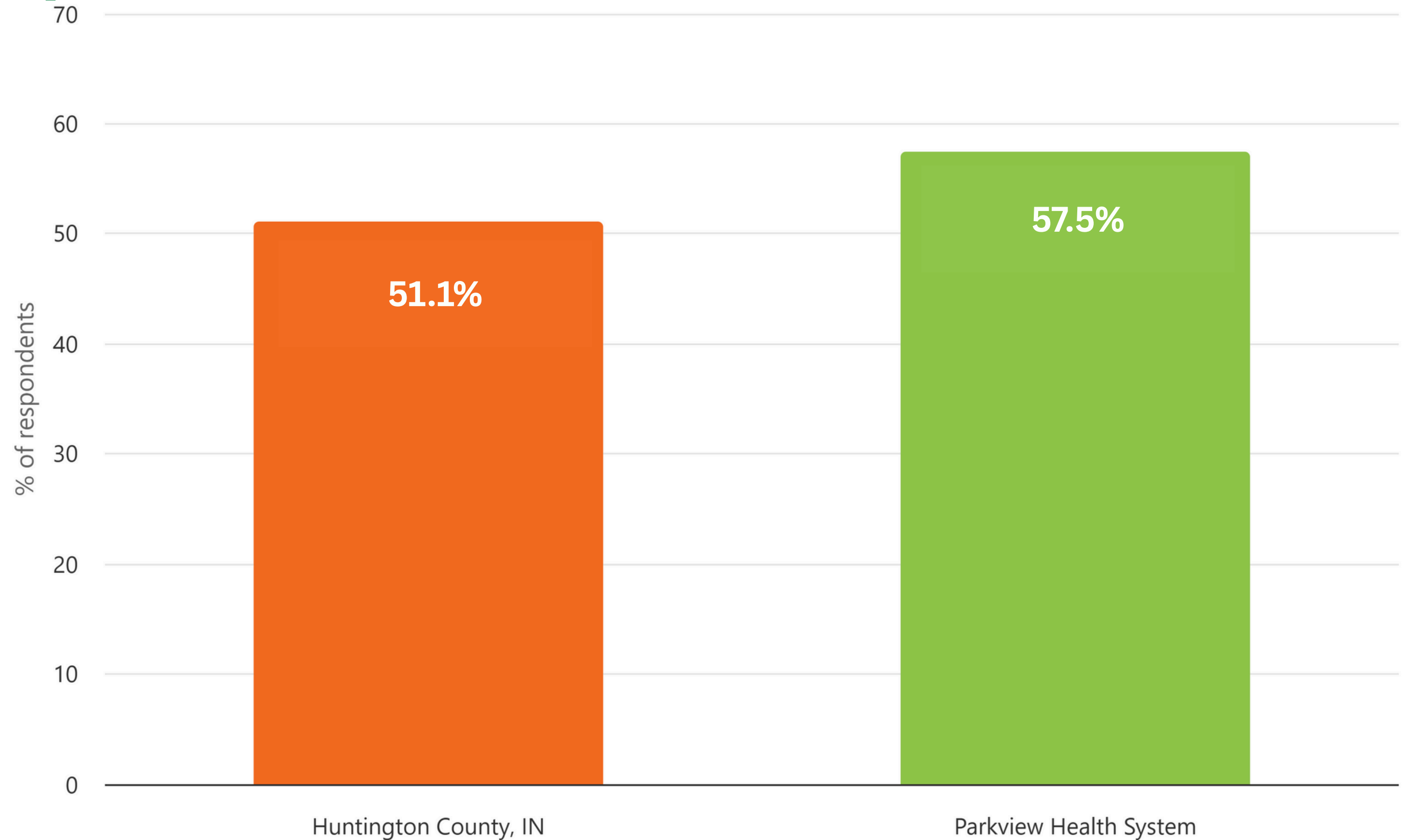

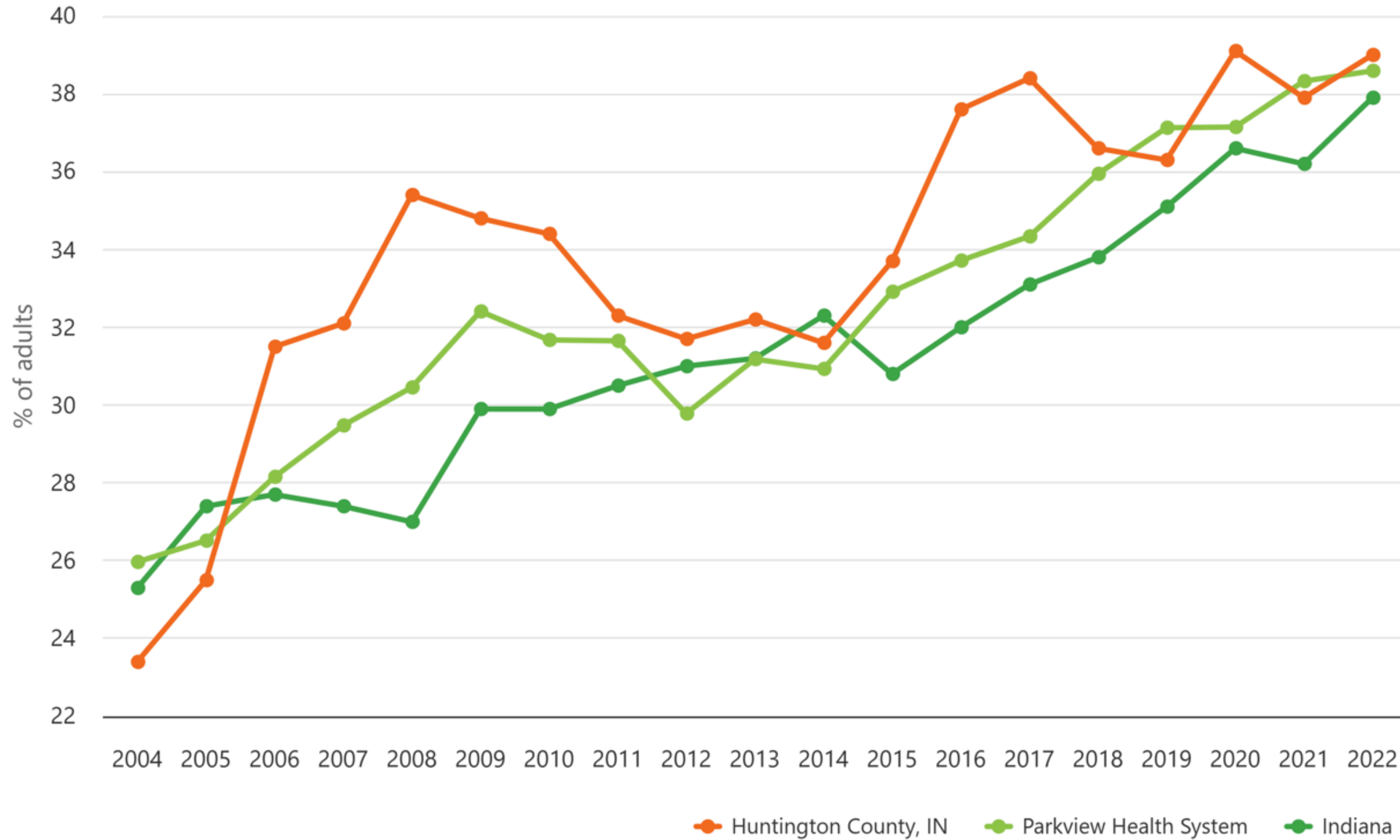

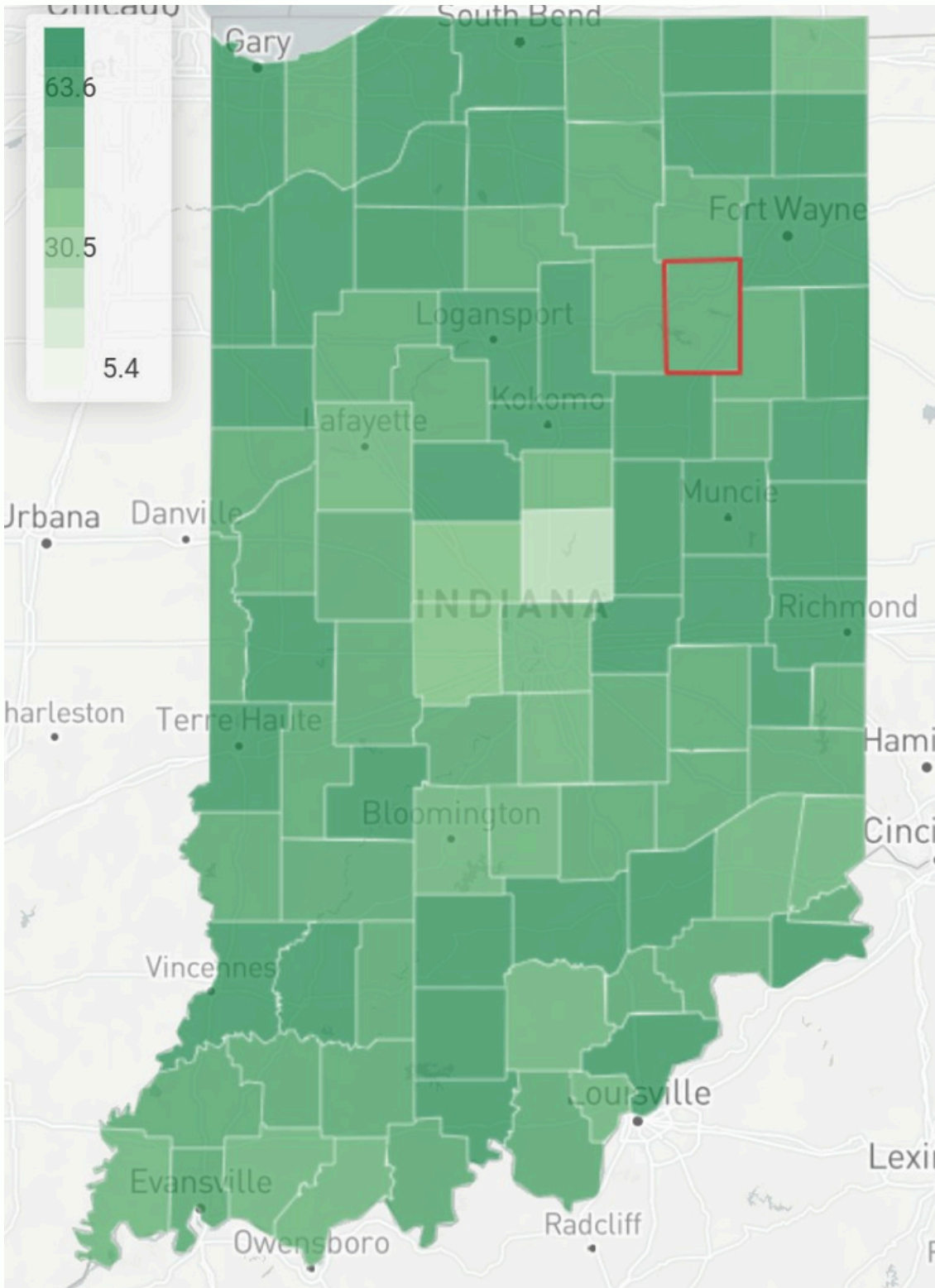

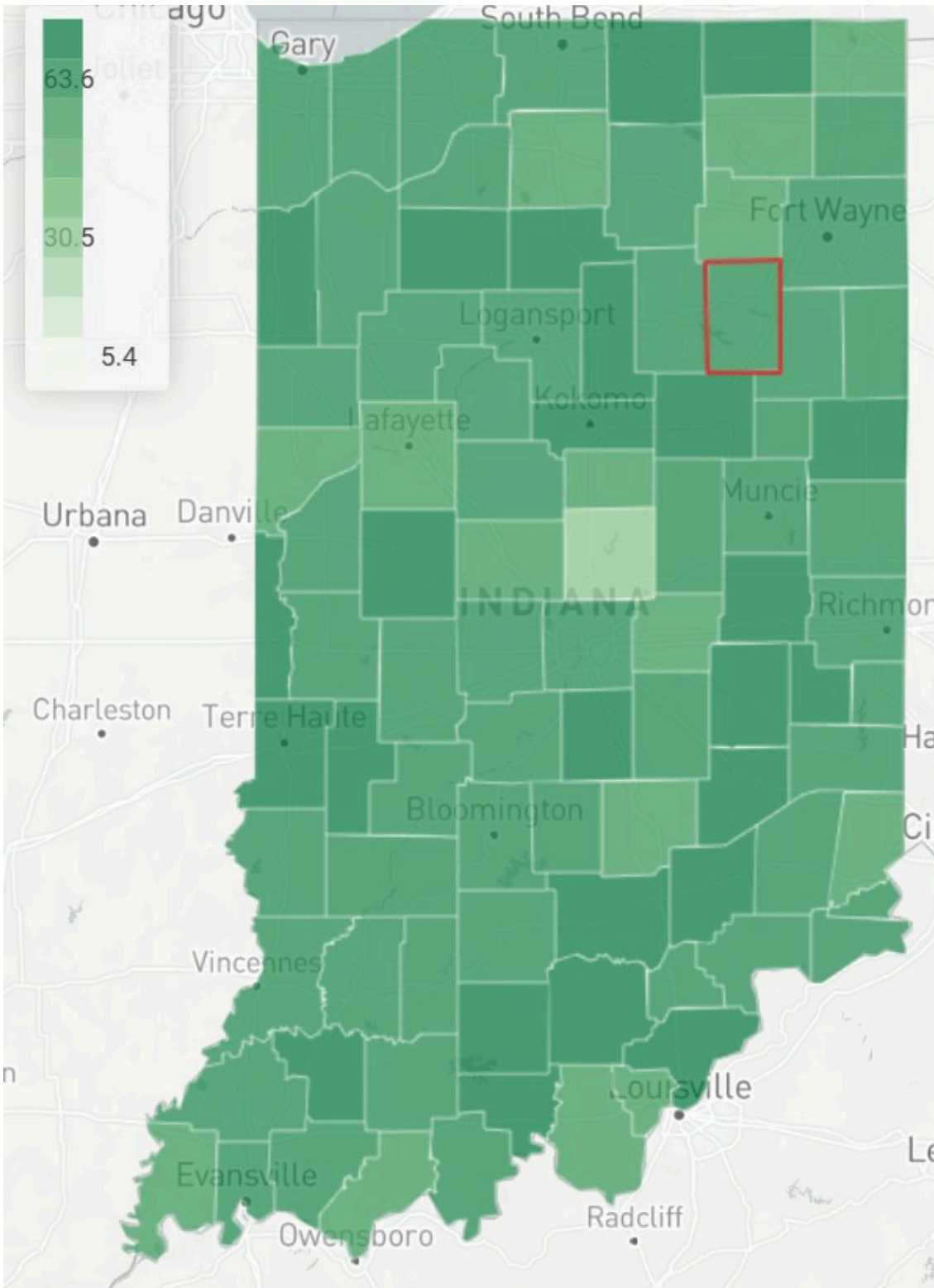

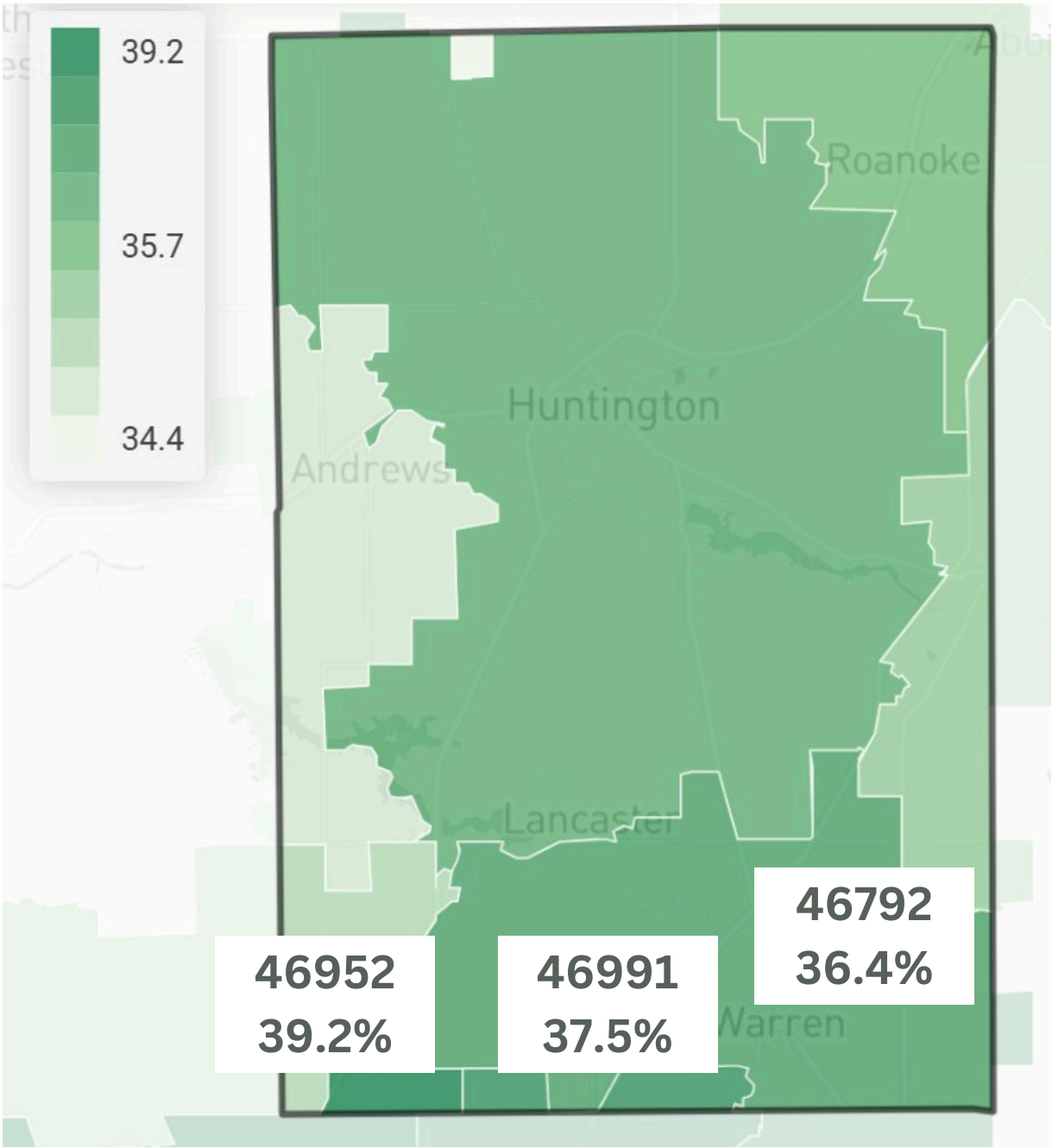

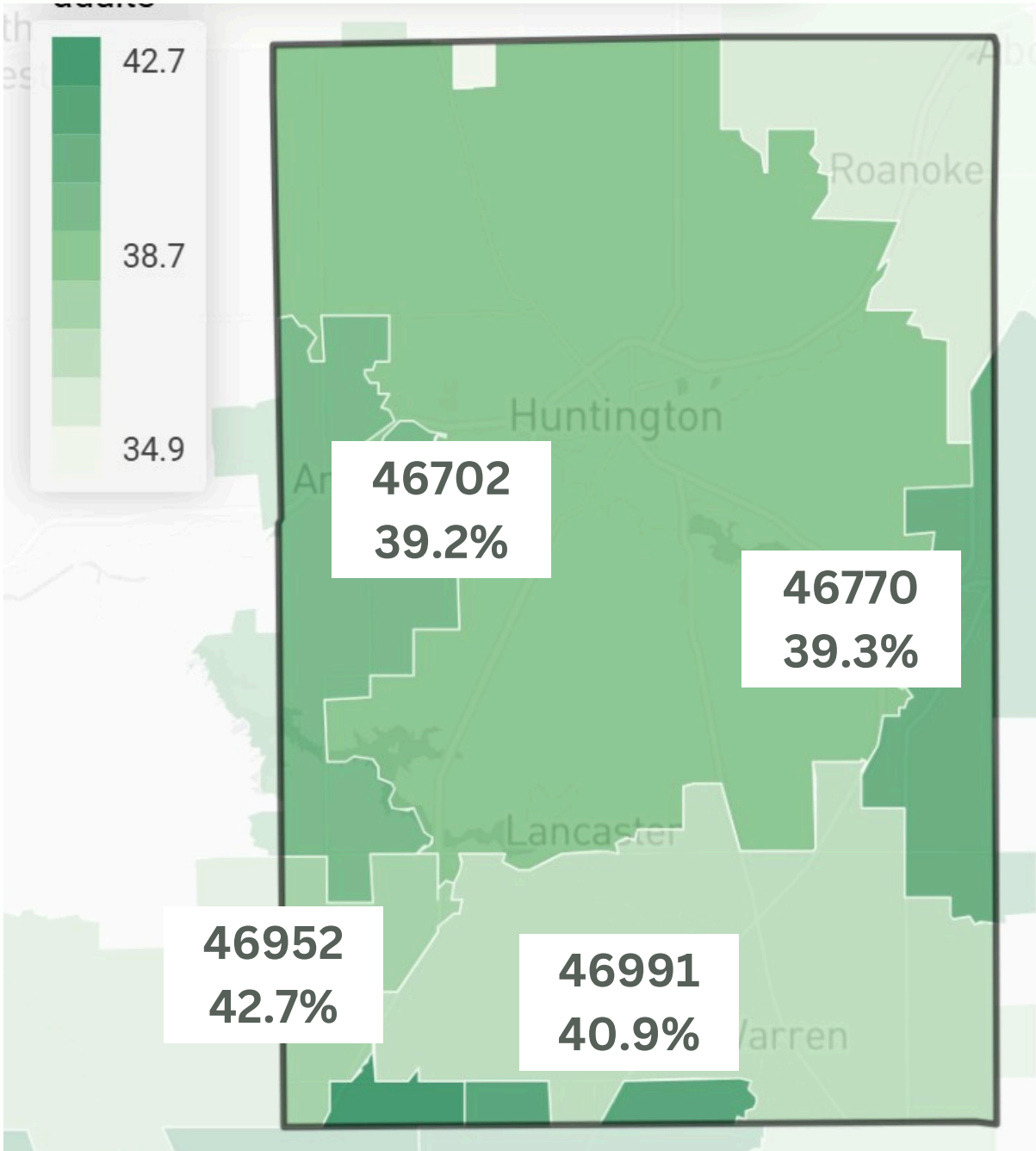

Summary of Community Survey Data and Local Health Statistics

Obesity

- The percentage of **adults with obesity** in Huntington County is **greater** than in Indiana and the Parkview Health service area, and is **steadily increasing**.
 - Though obesity rates are improving in some zip codes, several areas are still **above the county average** and **getting worse** over time, with the **highest** percentage observed for zip code **46952 (42.7%** as of 2022).
